

ON FUNDAMENTAL FOURIER COEFFICIENTS OF SIEGEL CUSP FORMS OF DEGREE 2

ABSTRACT. Let F be a Siegel cusp form of degree 2, even weight $k \geq 2$ and odd squarefree level N . We undertake a detailed study of the analytic properties of Fourier coefficients $a(F, S)$ of F at fundamental matrices S (i.e., with $-4 \det(S)$ equal to a fundamental discriminant). We prove that as S varies along the equivalence classes of fundamental matrices with $\det(S) \asymp X$, the sequence $a(F, S)$ has at least $X^{1-\varepsilon}$ sign changes, and takes at least $X^{1-\varepsilon}$ “large values”. Furthermore, assuming the Generalized Riemann Hypothesis as well as the refined Gan–Gross–Prasad conjecture, we prove the bound $|a(F, S)| \ll_{F, \varepsilon} \frac{\det(S)^{\frac{k}{2} - \frac{1}{2}}}{(\log |\det(S)|)^{\frac{1}{8} - \varepsilon}}$ for fundamental matrices S .

1. INTRODUCTION

Let $S_k(\Gamma_0^{(2)}(N))$ denote the space of Siegel cusp forms of degree 2 and weight k with respect to the congruence subgroup $\Gamma_0^{(2)}(N) \subseteq \mathrm{Sp}_4(\mathbb{Z})$ of level N . Any $F \in S_k(\Gamma_0^{(2)}(N))$ has a Fourier expansion of the form

$$(1) \quad F(Z) = \sum_{S \in \Lambda_2} a(F, S) e^{2\pi i \mathrm{Tr}(SZ)}, \quad Z \text{ in the Siegel upper half space,}$$

where the set Λ_2 consists of symmetric, semi-integral, positive-definite 2×2 matrices S , i.e.,

$$(2) \quad \Lambda_2 = \left\{ \begin{pmatrix} a & b/2 \\ b/2 & c \end{pmatrix}, \quad a, b, c \in \mathbb{Z}, \quad a > 0, \quad d := b^2 - 4ac < 0 \right\}.$$

For $S = \begin{pmatrix} a & b/2 \\ b/2 & c \end{pmatrix} \in \Lambda_2$, we define $\mathrm{disc}(S) = -4 \det(S) = b^2 - 4ac$. If $d = \mathrm{disc}(S)$ is a fundamental discriminant¹, then S is called *fundamental*. A fundamental S is automatically primitive (i.e., $\mathrm{gcd}(a, b, c) = 1$). Observe that if d is odd, then S is fundamental if and only if d is squarefree. The fundamental Fourier coefficients of Siegel cusp forms are deep and highly interesting objects. These are the basic building blocks, in the sense that one cannot use the theory of Hecke operators to relate the Fourier coefficients $a(F, S)$ at these matrices to those at simpler matrices. Furthermore, fundamental Fourier coefficients are closely related to central L -values.

In [Sah13, SS13] it was proved that if $k > 2$ is even and N is squarefree, then elements of $S_k(\Gamma_0^{(2)}(N))$ (under some mild assumptions) are uniquely determined by their fundamental Fourier coefficients. More precisely, it was proved there that *for k, N as above, if $F \in S_k(\Gamma_0^{(2)}(N))$ is non-zero and an eigenfunction of the $U(p)$ operators for $p|N$, then $a(F, S) \neq 0$ for infinitely many matrices S such that $\mathrm{disc}(S)$ is odd and squarefree.* This non-vanishing result is crucial for the existence of good Bessel models [PSS14, Lemma 5.1.1] and consequently was needed for removing a key assumption from theorems due to Furusawa [Fur93], Pitale–Schmidt [PS09a] and the third-named author [Sah09, Sah10, PSS14] on the degree 8 L -function on $\mathrm{GSp}_4 \times \mathrm{GL}_2$. Furthermore, there is a remarkable identity, explained in more detail in Section 1.3 below, relating squares of

(weighted averages of) fundamental Fourier coefficients and central values of dihedral twists of GSp_4 and GL_2 L -functions. Indeed, the fundamental Fourier coefficients are *unipotent periods* whose weighted averages are *Bessel periods* whose absolute squares are essentially central L -values of degree 8 L -functions, via the refined Gan–Gross–Prasad conjectures [Liu16].

Motivated by these connections, the objective of this paper is to understand better the nature of the fundamental Fourier coefficients. In particular, we investigate the following questions:

- Are there many *sign changes* among the fundamental Fourier coefficients?
- How *large* (in the sense of both lower and upper bounds) are the fundamental Fourier coefficients?

We emphasize that while these kinds of questions have been previously studied for the full sequence $a(F, S)$ ($S \in \Lambda_2$) of Fourier coefficients attached to F (see [CGK15, GS17, HZ18] for results on sign-changes and [Das20] for an Omega-result) there appears to be virtually no previous work in the more subtle setting where one restricts to fundamental Fourier coefficients. There has also been a fair bit of work on sign changes of *Hecke eigenvalues* of Siegel cusp forms [Koh07, PS08, RSW16, DK18] which can be combined with the Hecke relations [And74] to deduce sign changes among the $a(F, S)$ with $\mathrm{disc}(S) = dm^2$ where d is a *fixed* fundamental discriminant and m varies. This should make it clear that the problem of obtaining sign changes or growth asymptotics for Fourier coefficients *not* associated to fundamental discriminants is of a different flavor (and relatively easier). Our focus in this paper is on the subsequence of Fourier coefficients $a(F, S)$ with S restricted to matrices of fundamental discriminant, where these questions are more difficult.

1.1. Main results. Let $k > 2$ be an even integer and N be an odd squarefree integer. Fix $F \in S_k(\Gamma_0^{(2)}(N))$. If $N > 1$, assume that F is an eigenform for the $U(p)$ Hecke operator (see (52)) for the finitely many primes $p|N$; we make no assumptions concerning whether F is a Hecke eigenform at primes not dividing the level N . Our main result on sign changes is as follows.

Theorem A. (see Theorem 5.2) *For F as above with real Fourier coefficients one can fix M such that given $\varepsilon > 0$ and sufficiently large X , there are $\geq X^{1-\varepsilon}$ distinct odd squarefree integers $n_i \in [X, MX]$ and associated fundamental matrices $S_i \in \Lambda_2$ with $|\mathrm{disc}(S_i)| = n_i$, such that with the n_i ordered in increasing manner we have $a(F, S_i)a(F, S_{i+1}) < 0$.*

Thus, Theorem A asserts that there are at least $X^{1-\varepsilon}$ (strict) sign changes among the fundamental Fourier coefficients of discriminant $\asymp X$. Interestingly, this also improves the exponent of the non-vanishing results of [Sah13, SS13] mentioned earlier, where it was proved that there are $\gg_\varepsilon X^{5/8-\varepsilon}$ non-vanishing fundamental Fourier coefficients of discriminant up to X .

Another question left unanswered in all previous works is that of *lower bounds* for $|a(F, S)|$ with S fundamental. Let F be as above and fixed. A famous (and very deep) conjecture of Resnikoff and Saldana [RS74] predicts that for S a fundamental² matrix in Λ_2 ,

$$(3) \quad |a(F, S)| \ll_{F, \varepsilon} |\mathrm{disc}(S)|^{\frac{k}{2} - \frac{3}{4} + \varepsilon}.$$

We prove a lower bound for many fundamental Fourier coefficients with an exponent of the same strength.

Theorem B. (see Theorem 5.3) *For F as above, $\varepsilon > 0$ fixed, and all sufficiently large X there are $\geq X^{1-\varepsilon}$ distinct odd squarefree integers $n \in [X, 2X]$, with associated fundamental matrices S_n such that $|\mathrm{disc}(S_n)| = n$ and*

$$|a(F, S_n)| \geq n^{\frac{k}{2} - \frac{3}{4}} \exp\left(\frac{1}{82} \sqrt{\frac{\log n}{\log \log n}}\right).$$

Theorem B tells us that there are at least $X^{1-\varepsilon}$ fundamental Fourier coefficients of discriminant $\asymp X$ whose sizes are “large”. Incidentally, just like Theorem A, Theorem B also improves upon the exponent of the set of non-vanishing fundamental coefficients obtained in [SS13] from $5/8$ to 1 .

Next, we investigate *upper bounds* for the Fourier coefficients $|a(F, S)|$ for fundamental S . The best currently known bound is due to Kohnen [Koh93] who proved that $|a(F, S)| \ll_{F,\varepsilon} |\text{disc}(S)|^{\frac{k}{2}-\frac{13}{36}+\varepsilon}$. This bound is quite far from the conjectured true bound (3). In fact, even if one were to assume the Generalized Lindelöf hypothesis, one only obtains the upper bound $\ll_{F,\varepsilon} |\text{disc}(S)|^{\frac{k}{2}-\frac{1}{2}+\varepsilon}$ (as explained further below). Thus, the exponent $\frac{k}{2}-\frac{1}{2}$ appears to be a natural barrier. By employing probabilistic methods and assuming the Generalized Riemann Hypothesis (GRH) for several L -functions, we are able to go beyond this barrier for the first time.

Theorem C. (see Theorem 5.14) *Let $k > 2$ be an even integer and N be an odd squarefree integer. Fix $F \in S_k(\Gamma_0^{(2)}(N))$. Assume that the refined Gan–Gross–Prasad conjecture [Liu16, (1.1)] holds³ for Bessel periods of holomorphic cusp forms on $\text{SO}_5(\mathbb{A})$. Assume that GRH holds for L -functions in the Selberg class. Then we have*

$$|a(F, S)| \ll_{F,\varepsilon} \frac{|\text{disc}(S)|^{\frac{k}{2}-\frac{1}{2}}}{(\log |\text{disc}(S)|)^{\frac{1}{8}-\varepsilon}}$$

for fundamental matrices S .

We note that a bound similar to that obtained in Theorem C has been recently proved in the special case where F is a *Yoshida lift* by Blomer and Brumley [BB20, Corollary 4].

1.2. The reduction of Theorems A and B to half-integral weight forms. The proofs of Theorems A and B rely on reducing these questions to corresponding ones about cusp forms of weight $k - \frac{1}{2}$ on the upper half-plane, exploiting the Fourier-Jacobi expansion of F and the relation between Jacobi forms and classical cusp forms of half-integral weight. More precisely, the set of primes p such that the p 'th Fourier-Jacobi coefficient of F is non-zero has positive density in the set of all primes; fix *any* p in this set coprime to N . Using a classical construction going back to Eichler and Zagier in the case $N = 1$ and due to Manickam–Ramakrishnan [MR00] for squarefree N , we can now construct a non-zero cusp form h of level $4Np$ and weight $k - \frac{1}{2}$ whose Fourier coefficients $a(h, n)$ essentially equal some $a(F, S)$ with $|\text{disc}(S)| = n$.

From the above construction, Theorem A will follow if we can demonstrate $X^{1-\varepsilon}$ sign changes among the coefficients $a(h, n)$ of the half-integral weight form h for odd squarefree $n \asymp X$, which is exactly what we prove in Theorem 3.1, a result which builds upon works of Matomäki and Radziwiłł [MR15] and [LR19] and may be of independent interest. A point worth noting here is that h is *not* typically a Hecke eigenform (even when F is a Hecke eigenform) as the passage from Siegel cusp forms to Jacobi forms described above is not a functorial correspondence. The main ingredient for our proof of Theorem 3.1 is the demonstration of cancellation in sums of $a(h, n)$ over almost all short intervals together with bounds on their moments thereby providing a lower bound on sums of $|a(h, n)|$ over almost all short intervals. Combining the two results shows that over many short intervals the absolute value of the average of $a(h, n)$ is strictly smaller than that of $|a(h, n)|$. Consequently, a sign change of $a(h, n)$ occurs in many short intervals.

Likewise, Theorem B follows provided we can demonstrate suitable large values for $|a(h, n)|$. This is done in Section 4. The main result of that section, Theorem 4.1, says that there are at least $X^{1-\varepsilon}$ odd squarefree $n \asymp X$ with

$$|a(h, n)| \geq n^{\frac{k}{2}-\frac{3}{4}} \exp\left(\frac{1}{82} \sqrt{\frac{\log n}{\log \log n}}\right).$$

Theorem 4.1 generalizes recent work of Gun–Kohnen–Soundararajan [GKS20] which dealt with the case of h of level 4. The proof of Theorem 4.1 follows the “resonance method”-strategy of [Sou08, GKS20]; however there are additional complications coming from the level which we need to overcome. The starting point of the proof is to use Kohnen’s basis for $S_{k+\frac{1}{2}}^+(4N)$ consisting of newforms and an explicit form of Waldspurger’s formula to reduce the problem to showing large values for (a weighted average of) a particular central L -value, while controlling sizes of certain other central L -values (see Proposition 4.2 and the discussion after it, in particular estimates (31) and (32)). This is achieved by the resonance-method as in [GKS20]. A key technical input for this method is the evaluation of the first moment of twisted central L -values (Proposition 4.3), which is obtained following the method of [SY10]. Complications arising from the level show up here in a form of extra congruence and coprimality conditions, and these are dealt with as in [RS15].

Theorem C, unlike Theorems A and B, does not involve a reduction to half-integral weight forms. We explain the main ideas behind its proof in Section 1.4 further below.

Finally, we remark that a variant of the Fourier-Jacobi expansion trick sketched at the beginning of this subsection has been recently developed by Böcherer and Das to prove non-vanishing of fundamental Fourier coefficients of Siegel modular forms of degree n [BD18]. By using their variant, it seems plausible that the methods of this paper may allow one to extend Theorems A and B above to Siegel cusp forms of higher degree. We do not pursue this extension here.

1.3. Central L -values for dihedral twists of spin L -functions. For two matrices S_1, S_2 in Λ_2 , write $S_1 \sim S_2$ if there exists $A \in \mathrm{SL}_2(\mathbb{Z})$ such that $S_1 = {}^tAS_2A$. Let $F \in S_k(\Gamma_0^{(2)}(N))$ with $k > 2$ even and N odd and squarefree. Using the defining relation for Siegel cusp forms, we see that

$$(4) \quad a(F, S_1) = a(F, S_2) \quad \text{if } S_1 \sim S_2,$$

thus showing that $a(F, S)$ only depends on the $\mathrm{SL}_2(\mathbb{Z})$ -equivalence class of the matrix S . Let $d < 0$ be a fundamental discriminant, let Cl_K denote the ideal class group of $K = \mathbb{Q}(\sqrt{d})$, and let $w(K) \in \{2, 4, 6\}$ be the number of roots of unity in K . It is well-known that the $\mathrm{SL}_2(\mathbb{Z})$ -equivalence classes of matrices in Λ_2 of discriminant d are in natural bijective correspondence with the elements of Cl_K . So, for any character Λ of the finite group Cl_K , we can define

$$(5) \quad B(F, \Lambda) = \sum_{S \in \mathrm{Cl}_K} a(F, S)\Lambda(S),$$

which may be viewed as a Bessel period [DPSS20, Prop. 3.5].

The space $S_k(\Gamma_0^{(2)}(N))$ has a natural subspace $S_k(\Gamma_0^{(2)}(N))^{\mathrm{CAP}}$ spanned by the *Saito-Kurokawa lifts*. If F is a Saito-Kurokawa lift then $a(F, S)$ (for fundamental S) depends *only* on $d = \mathrm{disc}(S)$ and is fairly well-understood. In particular, for $F \in S_k(\Gamma_0^{(2)}(N))^{\mathrm{CAP}}$, the Bessel period $B(F, \Lambda)$ vanishes whenever $\Lambda \neq 1_K$, where 1_K denotes the trivial character of Cl_K . Now suppose that F is not a Saito-Kurokawa lift. Let ϕ be the adelization of F , and suppose that ϕ generates an irreducible automorphic representation π of $\mathrm{GSp}_4(\mathbb{A})$. Böcherer [Böc86] made the remarkable conjecture that $|B(F, 1_K)|^2 = A_F \cdot w(K)^2 \cdot |d|^{k-1} \cdot L(\frac{1}{2}, \pi \otimes \chi_d)$ where χ_d is the quadratic character associated to K/\mathbb{Q} and A_F is a constant depending only on F .

More generally, let $\mathcal{AJ}(\Lambda)$ be the automorphic representation of $\mathrm{GL}(2, \mathbb{A})$ given by the automorphic induction of Λ from K ; it is generated by (the adelization of) the dihedral modular form $\theta_\Lambda(z) = \sum_{0 \neq \mathfrak{a} \subset \mathfrak{o}_K} \Lambda(\mathfrak{a})e^{2\pi iN(\mathfrak{a})z}$ of weight 1. It is easy to check that $L(s, \pi \otimes \mathcal{AJ}(\Lambda)) = L(s, \pi)L(s, \pi \otimes \chi_d)$. Now, assume that the refined Gan-Gross-Prasad conjecture (see [DPSS20, Conjecture 1.12] and [Liu16, (1.1)]) for the pair (ϕ, Λ) holds true. In fact, this conjecture for $\Lambda = 1_K$ is now known thanks to work of Furusawa and Morimoto [FMng] (which combined with [DPSS20] completes the

proof of Böcherer’s conjecture) and the proof for general Λ has been recently announced by the same authors. Then Theorem 1.13 of [DPSS20] implies that under some mild assumptions,

$$(6) \quad |B(F, \Lambda)|^2 = c_F w(K)^2 |d|^{k-1} L\left(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)\right),$$

where c_F is an explicit non-zero constant depending only on F and $L(s, \pi \times \mathcal{AJ}(\Lambda))$ is the tensor product L -function of the spin (degree 4) L -function of π and the standard (degree 2) L -function of $\mathcal{AJ}(\Lambda)$. We show in Proposition 5.9 that a variant of (6), where the equality is replaced by an inequality, holds in a more general setup (assuming the refined Gan-Gross-Prasad conjecture).

The identities (5) and (6) demonstrate that the fundamental Fourier coefficients of Hecke eigenforms in $S_k(\Gamma_0^{(2)}(N))$ are intimately connected with central L -values of the degree 8 L -function $L(s, \pi \times \mathcal{AJ}(\Lambda))$ as Λ varies over the ideal class characters of K . By inverting (5), we can write

$$(7) \quad a(F, S) = \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}_K}} B(F, \Lambda) \Lambda^{-1}(S),$$

which expresses each fundamental $a(F, S)$ as a weighted average of the Bessel periods $B(F, \Lambda)$.

Now, combining (6) and (7) with Theorem B, we obtain the following corollaries.

Corollary 1.1. *Let π be a cuspidal automorphic representation of $\text{GSp}_4(\mathbb{A})$ that is not of Saito-Kurokawa type, such that π arises from a form in $S_k(\Gamma_0^{(2)}(N))$ with $k > 2$ even and N odd and squarefree. Fix $\varepsilon > 0$. Assume the refined Gan-Gross-Prasad conjecture [DPSS20, Conjecture 1.12]. Then for all sufficiently large X , there are $\geq X^{1-\varepsilon}$ negative fundamental discriminants d with $|d| \asymp X$ such that for $K = \mathbb{Q}(\sqrt{d})$,*

$$\frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}_K}} L\left(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)\right) \gg_{\pi} |d|^{-1/2} \exp\left(\frac{1}{82} \sqrt{\frac{\log |d|}{\log \log |d|}}\right).$$

By specializing further to the case of Yoshida lifts, we obtain the following application which is purely about central L -values of dihedral twists of *classical* newforms.

Corollary 1.2. *Let $k > 2$ be an even integer. Let N_1, N_2 be two positive, squarefree integers such that $M = \text{gcd}(N_1, N_2) > 1$. Let f be a holomorphic newform of weight $2k - 2$ on $\Gamma_0(N_1)$ and g be a holomorphic newform of weight 2 on $\Gamma_0(N_2)$. Assume that for all primes p dividing M the Atkin-Lehner eigenvalues of f and g coincide. Fix $\varepsilon > 0$. Then for all sufficiently large X , there are $\geq X^{1-\varepsilon}$ negative fundamental discriminants d with $|d| \asymp X$ with the property that there exists an ideal class group character Λ of $K = \mathbb{Q}(\sqrt{d})$ such that*

$$L\left(\frac{1}{2}, f \times \mathcal{AJ}(\Lambda)\right) L\left(\frac{1}{2}, g \times \mathcal{AJ}(\Lambda)\right) \gg_{f,g} |d|^{-1/2} \exp\left(\frac{1}{82} \sqrt{\frac{\log |d|}{\log \log |d|}}\right).$$

Corollary 1.2 strengthens the main theorem of [SS13] which showed the existence of Λ with (simultaneous) non-vanishing for $L(\frac{1}{2}, f \times \mathcal{AJ}(\Lambda))$ and $L(\frac{1}{2}, g \times \mathcal{AJ}(\Lambda))$ and remarked: “while our method gives a lower bound on the number of non-vanishing twists, it does not give a lower bound on the size of the non-vanishing L -value itself.” Corollary 1.2 successfully achieves this.

1.4. Fractional moments of L -values. Combining (6) and (7), we can write

$$(8) \quad |a(F, S)| \ll_F |d|^{\frac{k}{2}-\frac{1}{2}} \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}_K}} \sqrt{L\left(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)\right)}.$$

From the above, we see that the Generalized Lindelöf hypothesis for $L(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda))$ implies that $|a(F, S)| \ll_{F,\varepsilon} |\text{disc}(S)|^{\frac{k}{2}-\frac{1}{2}+\varepsilon}$, which is still quite far from (3).

Therefore, in order to prove Theorem C, we need to go beyond the bound obtained by a naive application of the Generalized Lindelöf hypothesis. We do this by using Soundararajan’s method

[Sou09] for bounding moments of L -functions. Assuming GRH, we prove the following bound (Theorem 6.1) which, thanks to (8), implies Theorem C:

$$\frac{1}{|\widehat{\text{Cl}}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \sqrt{L(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda))} \ll_{\varepsilon} \frac{1}{(\log |d|)^{\frac{1}{8} - \varepsilon}}.$$

The main contribution to the moments of $L(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda))$ will come from its large values and we expect that these should be approximated by the large values of $\exp(\sum_{p^n < |d|} \frac{b_{\pi \times \mathcal{AJ}(\Lambda)}(p^n)}{p^{n/2}})$, where $b_{\pi \times \mathcal{AJ}(\Lambda)}(n)$ is the n 'th coefficient of the Dirichlet series of $\log L(s, \pi \times \mathcal{AJ}(\Lambda))$. For ease of discussion let us assume here that d is prime, $N = 1$, and π transfers to a *cuspidal* representation of GL_4^4 . Separately analyzing the primes, squares of primes and higher prime powers we show under GRH

$$\sum_{p^n < |d|} \frac{b_{\pi \times \mathcal{AJ}(\Lambda)}(p^n)}{p^{n/2}} = \sum_{p < |d|} \frac{b_{\pi}(p)b_{\mathcal{AJ}(\Lambda)}(p)}{\sqrt{p}} - \frac{1}{2} \log \log |d| (1 + o(1))$$

where $b_{\pi}(p), b_{\mathcal{AJ}(\Lambda)}(p)$ respectively denote the p 'th coefficient of the Dirichlet series of $\log L(s, \pi)$ and $\log L(s, \mathcal{AJ}(\Lambda))$. For primes with $(\frac{d}{p}) = 1$ so that $p\mathcal{O}_K = \mathfrak{p}\bar{\mathfrak{p}}$, as Λ varies over $\widehat{\text{Cl}}_K$, we expect that $b_{\mathcal{AJ}(\Lambda)}(p) = \Lambda(\mathfrak{p}) + \Lambda(\mathfrak{p})^{-1}$ behaves like the random variable $X_p + X_p^{-1}$ where $\{X_p\}_p$ are iid random variables uniformly distributed on the unit circle (if $(\frac{d}{p}) = -1$, $b_{\mathcal{AJ}(\Lambda)}(p) = 0$). Consequently the sum on the r.h.s. above is modelled by the random variable $\sum_{p < |d|} \frac{b_{\pi}(p)(X_p + X_p^{-1})}{\sqrt{p}} \mathbf{1}_{(\frac{d}{p})=1}$, which can be shown to have a normal limiting distribution as $d \rightarrow \infty$ with mean 0 and variance $2 \sum_{p < |d|} \frac{b_{\pi}(p)^2}{p} \mathbf{1}_{(\frac{d}{p})=1} \sim \log \log |d|$, which we prove under GRH. The preceding discussion suggests

$$\begin{aligned} \frac{1}{|\widehat{\text{Cl}}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \sqrt{L(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda))} &\asymp (\log |d|)^{-1/4} \mathbb{E} \left(\exp \left(\frac{1}{2} \sum_{p < |d|} \frac{b_{\pi}(p)(X_p + X_p^{-1}) \mathbf{1}_{(\frac{d}{p})=1}}{\sqrt{p}} \right) \right) \\ &\asymp (\log |d|)^{-1/8} \end{aligned}$$

where in the last step we have used that the moment generating function of a normal random variable X with mean 0 and variance σ^2 is given by $\mathbb{E}(e^{zX}) = e^{\frac{1}{2}z^2\sigma^2}$. Remarkably, Soundararajan's method allows us to make this heuristic argument rigorous for the upper bound, up to the loss of a factor $(\log |d|)^{\varepsilon}$, which occurs due to a sub-optimal treatment of the large primes.

1.5. Notations. We use the notation $A \ll_{x,y,z} B$ to signify that there exists a positive constant C , depending at most upon x, y, z , so that $|A| \leq C|B|$. The symbol ε will denote a small positive quantity. We write $A(x) = O_y(B(x))$ if there exists a positive real number M (depending on y) and a real number x_0 such that $|A(x)| \leq M|B(x)|$ for all $x \geq x_0$.

For a positive integer n with prime factorization $n = \prod_{i=1}^k p_i^{\alpha_i}$, we define $\omega(n) = k$, $\Omega(n) = \sum_{i=1}^k \alpha_i$. We let $\mu(n)$ denote the Möbius function, i.e., $\mu(n) = (-1)^{\omega(n)}$ if $\omega(n) = \Omega(n)$, and $\mu(n) = 0$ otherwise. We say that n is squarefree if $\mu(n) \neq 0$. We let (a, b) or $\text{gcd}(a, b)$ denote the greatest common divisor of a and b .

We say that d is a fundamental discriminant if d is the discriminant of the field $\mathbb{Q}(\sqrt{d})$. For a fundamental discriminant d , we let χ_d be the associated quadratic Dirichlet character. Given any representation π of a group, we let $\hat{\pi}$ denote the contragredient, and V_{π} denote the representation space. We use \mathbb{A} to denote the ring of adèles over \mathbb{Q} and we use \mathbb{A}_F to denote the ring of adèles over F for a general number field F . If G is a reductive group such that the local Langlands correspondence is known for each $G(F_v)$ and π is an automorphic representation of $G(\mathbb{A}_F)$, then we

formally (as an Euler product over finite places) define the L -function $L(s, \rho(\pi)) := L(s, \pi, \rho)$ for each finite dimensional representation ρ of the dual group. All L -functions in this paper will denote the finite part of the L -function (i.e., without the archimedean factors), so that for a number field F and an automorphic representation π of $\mathrm{GL}_n(F)$, we have $L(s, \pi) = \prod_{v < \infty} L(s, \pi_v)$. All L -functions will be normalized to take $s \mapsto 1 - s$. For an integer N we denote $L^N(s, \pi) = \prod_{v \nmid N} L(s, \pi_v)$. Given a reductive group G and two irreducible automorphic representations $\pi = \otimes_v \pi_v$ and $\sigma = \otimes_v \sigma_v$ of $G(\mathbb{A}_F)$, we say that π and σ are nearly equivalent if $\pi_v \simeq \sigma_v$ for all but finite many places v of F .

2. PRELIMINARIES ON HALF INTEGRAL WEIGHT FORMS

The goal of this section is to set up some notation and lay out some key properties concerning cusp forms of half-integral weight on the complex upper half-plane.

2.1. Notations. The group $\mathrm{SL}_2(\mathbb{R})$ acts on the upper half-plane \mathbb{H} by $\gamma z = \frac{az+b}{cz+d}$, where $\gamma = \begin{pmatrix} a & b \\ c & d \end{pmatrix}$ and $z = x + iy$. For a positive integer N , let $\Gamma_0(N)$ denote the congruence subgroup consisting of matrices $\begin{pmatrix} a & b \\ c & d \end{pmatrix}$ in $\mathrm{SL}_2(\mathbb{Z})$ such that N divides c . For a complex number z , let $e(z)$ denote $e^{2\pi iz}$.

Let $\theta(z) = \sum_{n=-\infty}^{\infty} e(n^2 z)$ be the standard theta function on \mathbb{H} . If $A = \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \Gamma_0(4)$, we have $\theta(Az) = j(A, z)\theta(z)$, where $j(A, z)$ is the so-called θ -multiplier. For an explicit formula for $j(A, z)$, see [Shi73, (1.10)]. Let $S_{k+\frac{1}{2}}(4N)$ denote the space of holomorphic cusp forms of weight $k + \frac{1}{2}$ for the group $\Gamma_0(4N)$. In other words, a function $f : \mathbb{H} \rightarrow \mathbb{C}$ belongs to $S_{k+\frac{1}{2}}(4N)$ if

- i) $f(Az) = j(A, z)^{2k+1} f(z)$ for every $A = \begin{pmatrix} a & b \\ c & d \end{pmatrix} \in \Gamma_0(4N)$,
- ii) f is holomorphic,
- iii) f vanishes at the cusps.

Any $f \in S_{k+\frac{1}{2}}(4N)$ has the Fourier expansion

$$f(z) = \sum_{n>0} a(f, n)e(nz).$$

We let $c(f, n)$ denote the “normalized” Fourier coefficients, defined by

$$c(f, n) = a(f, n)n^{\frac{1}{4}-\frac{k}{2}}.$$

For $f, g \in S_{k+\frac{1}{2}}(4N)$, we define the Petersson inner product $\langle f, g \rangle$ by

$$\langle f, g \rangle = [\mathrm{SL}_2(\mathbb{Z}) : \Gamma_0(4N)]^{-1} \int_{\Gamma_0(4N) \backslash \mathbb{H}} f(z) \overline{g(z)} y^{k+\frac{1}{2}} \frac{dx dy}{y^2}.$$

2.2. The Kohnen plus space and decomposition into old and newspaces. Fix positive integers k, N such that N is odd and squarefree. We recall the definition of the Kohnen plus space $S_{k+\frac{1}{2}}^+(4N) \subseteq S_{k+\frac{1}{2}}(4N)$. The space $S_{k+\frac{1}{2}}^+(4N)$ consists of all forms f in $S_{k+\frac{1}{2}}(4N)$ for which $a(f, n) = 0$ whenever $n \equiv (-1)^{k+1}$ or $2 \pmod{4}$. According to the results of [Koh82], there exists a canonically defined subspace $S_{k+\frac{1}{2}}^{+, \text{new}}(4N) \subset S_{k+\frac{1}{2}}^+(4N)$ and a decomposition

$$(9) \quad S_{k+\frac{1}{2}}^+(4N) = \bigoplus_{\substack{r, \ell \geq 1 \\ r\ell \mid N}} S_{k+\frac{1}{2}}^{+, \text{new}}(4\ell) |U(r^2),$$

where we define

$$(10) \quad f|U(r^2) = r^{\frac{1}{2}-k} \sum_{n>0} a(f, r^2n)e(nz).$$

It is known [Shi73, Prop. 1.5] that if $(r, \ell) = 1$, then $U(r^2)$ takes $S_{k+\frac{1}{2}}(4\ell)$ to $S_{k+\frac{1}{2}}(4r\ell)$. It is also useful to note that

$$(11) \quad c(f|U(r^2), n) = c(f, r^2n).$$

2.3. Hecke operators and the Shimura correspondence. For all primes p coprime to N there exist Hecke operators $T(p^2)$ acting on the space $S_{k+\frac{1}{2}}(4N)$; see [Shi73, Thm. 1.7]. A *newform* in $S_{k+\frac{1}{2}}^{+, \text{new}}(4N)$ is defined to be an element of $S_{k+\frac{1}{2}}^{+, \text{new}}(4N)$ that is an eigenfunction of the Hecke operators $T(p^2)$ for $p \nmid N$. The newforms are uniquely determined up to multiplication by non-zero complex numbers and are in fact also eigenforms for the operators $U(p^2)$ for all $p|N$ [Koh82, Theorem 2]. The space $S_{k+\frac{1}{2}}^{+, \text{new}}(4N)$ has an orthogonal basis consisting of newforms.

According to the Shimura lifting [Shi73], as refined by Kohnen in [Koh82], there is an isomorphism

$$(12) \quad S_{k+\frac{1}{2}}^{+, \text{new}}(4N) \xrightarrow{\sim} S_{2k}^{\text{new}}(N)$$

as *Hecke modules*, where $S_{2k}^{\text{new}}(N)$ is the orthogonal complement of the space of cuspidal oldforms of weight $2k$ for $\Gamma_0(N)$ as defined by Atkin–Lehner [AL70]. The Shimura lifting (12) takes each newform in $S_{k+\frac{1}{2}}^{+, \text{new}}(4N)$ (as defined above) to a newform (in the sense of Atkin–Lehner [AL70, Lemma 18]) in $S_{2k}^{\text{new}}(N)$ with the same Hecke eigenvalues. More precisely, if $f \in S_{k+\frac{1}{2}}^{+, \text{new}}(4N)$ is a newform, and $g \in S_{2k}^{\text{new}}(N)$ is the Shimura lift of f according to (12), then for each prime $p \nmid N$ there exists a real number $\lambda_f(p) \in [-2, 2]$ (the normalized Hecke eigenvalue) such that

$$f|T(p^2) = \lambda_f(p)p^{k-\frac{1}{2}}f, \quad g|T(p) = \lambda_f(p)p^{k-\frac{1}{2}}g.$$

In view of (9), a basis of $S_{k+\frac{1}{2}}^+(4N)$ consisting of eigenforms for $T(p^2)$, $p \nmid N$, is given by

$$(13) \quad \mathcal{B}_{k+\frac{1}{2}, 4N} = \bigcup_{r, \ell \geq 1} \{f|U(r^2) : f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}\},$$

where $\mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}$ is an (orthogonal) basis of $S_{k+\frac{1}{2}}^{+, \text{new}}(4\ell)$ consisting of newforms. Note however that all members of $\mathcal{B}_{k+\frac{1}{2}, 4N}$ are not necessarily orthogonal to each other. The following result will be useful for us.

Lemma 2.1. *Let r, ℓ be positive, odd, squarefree integers with $(r, \ell) = 1$ and let $f \in S_{k+\frac{1}{2}}^{+, \text{new}}(4\ell)$ be a newform. Then for any odd squarefree integer n , putting $d = (-1)^k n$, we have*

$$c(f|U(r^2), n) = c(f, r^2n) = c(f, n) \prod_{p|r} \left(\lambda_f(p) - \frac{1}{\sqrt{p}} \left(\frac{d}{p} \right) \right).$$

Additionally, for any odd integer $r \geq 1$ with $(r, \ell) = 1$ we have

$$|c(f, r^2n)| \leq 3^{\Omega(r)} |c(f, n)|.$$

Proof. The first statement follows from [Shi73, Corollary 1.8 (i)]. Using that $|\lambda_f(p)| \leq 2$ and applying [Shi73, Corollary 1.8 (ii)] the second claim follows by a simple induction argument. It suffices to show for each $p \nmid 2\ell$ that

$$|c(f, p^{2m}n)| \leq 3^m |c(f, n)|.$$

The case $m = 0$ is trivial and $m = 1$ follows from the first claim of the lemma. By [Shi73, Corollary 1.8 (ii)] we have for any $m \geq 1$

$$c(f, p^{2m+2}n) = \lambda_f(p)c(f, p^{2m}n) - (-1)^{k(p^2-1)/2}c(f, p^{2m-2}n).$$

Hence, for $m \geq 1$ we get that

$$\begin{aligned} |c(f, p^{2m+2}n)| &\leq 2|c(f, p^{2m}n)| + |c(f, p^{2m-2}n)| \\ &\leq (2 \cdot 3^m + 3^{m-1})|c(f, n)| \leq 3^{m+1}|c(f, n)|. \end{aligned}$$

□

2.4. An explicit version of Waldspurger's formula. A well-known formula of Waldspurger [Wal85] that was refined and made explicit in special cases by Kohlen [Koh85], expresses the squares of Fourier coefficients of half-integral weight eigenforms in terms of central L -values. We state a version of it below for elements of the basis (13).

Proposition 2.2. *Let r, ℓ be positive, odd, squarefree integers with $(r, \ell) = 1$. Let f be a newform in $S_{k+\frac{1}{2}}^{+, \text{new}}(4\ell)$ and let $g \in S_{2k}^{\text{new}}(\ell)$ be the Shimura lift of f . Then, for any squarefree positive integer n with $(n, 4\ell) = 1$, and $d = (-1)^k n$, we have*

$$\frac{|c(f|U(r^2), n)|^2}{\langle f, f \rangle} = 2^{\omega(\ell)} \frac{L(\frac{1}{2}, g \otimes \chi_d)}{\langle g, g \rangle} \frac{(k-1)!}{\pi^k} \left(\prod_{p|r} \left(\lambda_f(p) - \frac{1}{\sqrt{p}} \left(\frac{d}{p} \right) \right) \right)^2$$

provided that

- i) $d \equiv 1 \pmod{4}$
- ii) for each prime $p|\ell$, we have $\left(\frac{d}{p}\right) = w_p$, where w_p is the eigenvalue for the Atkin-Lehner operator at p acting on g .

If either of the two conditions above are not met, then $c(f|U(r^2), n) = 0$.

Proof. This follows from Corollary 1 of [Koh85], Proposition 4 of [Koh82], and Lemma 2.1. □

2.5. Estimates on moments of Fourier coefficients.

Proposition 2.3. *Let $f \in S_{k+\frac{1}{2}}^+(4N)$ where N is odd and squarefree. Then there exists $M \geq 2$ such that for all sufficiently large X ,*

$$(14) \quad \sum_{\substack{X \leq n \leq MX \\ (n, 2N)=1}} |c(f, n)|^2 \mu^2(n) \asymp_{f, M} X$$

and for any $\varepsilon > 0$

$$(15) \quad \sum_{\substack{X \leq n \leq 2X \\ (n, 2N)=1}} |c(f, n)|^4 \mu^2(n) \ll_{f, \varepsilon} X^{1+\varepsilon}.$$

Proof. We first prove (14). For the upper bound we use that $y^{k+1/2}|f(z)|$ is bounded on \mathbb{H} and hence we have

$$(16) \quad \sum_{\substack{X \leq n \leq 2X \\ (n, 2N)=1}} |c(f, n)|^2 \mu^2(n) \leq \sum_{X \leq n \leq 2X} |c(f, n)|^2 \ll \frac{1}{X^{k-1/2}} \sum_n |c(f, n)|^2 n^{k-\frac{1}{2}} e^{-4\pi n/X}$$

$$= \frac{1}{X^{k-1/2}} \int_0^1 |f(x + i/X)|^2 dx \ll_f X.$$

For the lower bound, we use a result obtained in the proof of [Sah13, Proposition 3.7], which gives for any $M \geq 1$ that

$$\sum_{\substack{n \leq MX \\ (n, 2N)=1}} |c(f, n)|^2 \mu^2(n) e^{-n/(X\sqrt{M})} \gg_f X\sqrt{M}.$$

Using (16) along with partial summation we can bound the tail end of the sum as follows

$$\sum_{\substack{n \geq MX \\ (n, 2N)=1}} |c(f, n)|^2 \mu^2(n) e^{-n/(X\sqrt{M})} \ll_f M e^{-\sqrt{M}} X.$$

Combining the two bounds above we have for M sufficiently large that

$$\begin{aligned} \sum_{\substack{n \leq MX \\ (n, 2N)=1}} |c(f, n)|^2 \mu^2(n) &\geq \sum_{\substack{n \leq MX \\ (n, 2N)=1}} |c(f, n)|^2 \mu^2(n) e^{-n/(X\sqrt{M})} \\ &= \sum_{\substack{n \geq 1 \\ (n, 2N)=1}} |c(f, n)|^2 \mu^2(n) e^{-n/(X\sqrt{M})} + O_f(M e^{-\sqrt{M}} X) \gg_f X\sqrt{M}. \end{aligned}$$

Finally, we note that by (16) the contribution from terms to the l.h.s. above with $n \leq X$ is $O_f(X)$, which completes the proof of the lower bound in (14).

For the proof of (15), we use (13) to reduce to the case $f = f_1|U(r^2)$ where $f_1 \in S_{k+\frac{1}{2}}^{+, \text{new}}(4\ell)$ is a newform with $r\ell|N$. Using Proposition 2.2, it now suffices to prove that

$$\sum_{|d| \leq X}^b L\left(\frac{1}{2}, g \otimes \chi_d\right)^2 \ll_{g, \varepsilon} X^{1+\varepsilon}$$

where g is the Shimura lift of f_1 and the sum is over fundamental discriminants d . This follows from the approximate functional equation and Heath-Brown's quadratic large sieve [HB95], using a straightforward modification of the proof of [HB95, Theorem 2] (see also [SY10, Corollary 2.5]). \square

3. SIGN CHANGES FOR COEFFICIENTS OF HALF-INTEGRAL WEIGHT FORMS

3.1. Statement of main result. Throughout this section let $k \geq 2$ be an integer and $N \geq 1$ be odd and squarefree. The main theorem to be proved in this section is

Theorem 3.1. *Let $f \in S_{k+\frac{1}{2}}^+(4N)$ be a fixed cusp form whose Fourier coefficients $c(f, n)$ are all real. Then there exists $M \geq 2$ such that given any $\varepsilon > 0$, the sequence $\{c(f, n)\}_{\substack{X \leq n \leq MX \\ 2n \text{ is squarefree} \\ (n, N)=1}}$ has at*

least $\gg_{f, M, \varepsilon} X^{1-\varepsilon}$ sign changes.

The main novelty here is that this result holds for all cusp forms $f \in S_{k+\frac{1}{2}}^+(4N)$, not just Hecke eigenforms, and this is crucial for our later application. Previously it was not apparently even known that there are infinitely many sign changes of $c(f, n)$ as n ranges over squarefree integers for $f \in S_{k+\frac{1}{2}}^+(4N)$.

Our proof builds upon the methods developed in [MR15, LR19] and relies upon the following two propositions. The first of which shows that the size of $|c(f, n)|$ is relatively well-behaved for most short intervals $[x, x + y]$.

Proposition 3.2. *Let $f \in S_{k+\frac{1}{2}}^+(4N)$. There exists $M \geq 2$ such that given any $\varepsilon > 0$ and $2 \leq y \leq X/2$ there are $\gg_{f,M,\varepsilon} X^{1-\frac{3}{2}\varepsilon}$ integers $X \leq x \leq MX$ such that*

$$\sum_{\substack{x \leq n \leq x+y \\ (n,2N)=1}} |c(f,n)|\mu^2(n) > \frac{y}{X^\varepsilon}.$$

Our other main proposition shows that we can obtain square-root cancellation in sums of $c(f,n)$ over almost all short intervals $[x, x+y]$.

Proposition 3.3. *Let $f \in S_{k+\frac{1}{2}}^+(4N)$. Then for $1 \leq y \leq X^{\frac{1}{205}}$ we have that*

$$\sum_{X \leq x \leq 2X} \left| \sum_{\substack{x \leq n \leq x+y \\ (n,2N)=1}} c(f,n)\mu^2(n) \right| \ll_f X\sqrt{y}.$$

We will now prove Theorem 3.1 using Propositions 3.2 and 3.3. The proof of Propositions 3.2 and 3.3 will be given in Sections 3.2 and 3.3, respectively.

Proof of Theorem 3.1. Observe that if the Fourier coefficients $c(f,n)$ are real and

$$\left| \sum_{\substack{x \leq n \leq x+y \\ (n,2N)=1}} c(f,n)\mu^2(n) \right| < \sum_{\substack{x \leq n \leq x+y \\ (n,2N)=1}} |c(f,n)|\mu^2(n)$$

then the interval $[x, x+y]$ must contain a sign change of $c(f,n)$ where $n \in [x, x+y]$ ranges over odd squarefree integers that are coprime to N . We will show that for most integers $X \leq x \leq MX$ that the above inequality holds for intervals of length $y = X^{6\varepsilon}$.

By Chebyshev's inequality, the number of integers $X \leq x \leq MX$ for which

$$(17) \quad \left| \sum_{\substack{x \leq n \leq x+y \\ (n,2N)=1}} c(f,n)\mu^2(n) \right| \leq \frac{y}{X^\varepsilon}$$

does not hold is

$$\leq \frac{X^\varepsilon}{y} \sum_{X \leq x \leq MX} \left| \sum_{\substack{x \leq n \leq x+y \\ (n,2N)=1}} c(f,n)\mu^2(n) \right| \ll_{f,M} \frac{X^{1+\varepsilon}}{\sqrt{y}} = X^{1-2\varepsilon},$$

where we have used Proposition 3.3 in the last inequality. By Proposition 3.2 we have that

$$(18) \quad \sum_{\substack{x \leq n \leq x+y \\ (n,2N)=1}} |c(f,n)|\mu^2(n) > \frac{y}{X^\varepsilon}$$

for all integers $X \leq x \leq MX$ outside an exceptional set of size $\ll_{f,M,\varepsilon} X^{1-3\varepsilon/2}$. Hence, there exist at least $\gg_{f,M,\varepsilon} X^{1-3\varepsilon/2}$ integers $X \leq x \leq MX$ such that (17) and (18) hold. Therefore, we obtain at least $\gg_{f,M,\varepsilon} \frac{X^{1-3\varepsilon/2}}{y} = X^{1-15\varepsilon/2}$ sign changes of $c(f,n)$ along integers $X \leq n \leq MX$, that are odd, squarefree, and coprime to N . \square

3.2. Proof of Proposition 3.2. We first prove the following result, which is an easy consequence of Proposition 2.3.

Lemma 3.4. *Let $f \in S_{k+\frac{1}{2}}^+(4N)$. Then there exists $M \geq 2$ such that given any $\varepsilon > 0$*

$$(19) \quad \sum_{\substack{X \leq n \leq MX \\ (n,2N)=1 \\ |c(f,n)| \leq X^\varepsilon}} |c(f,n)|\mu^2(n) \gg_{f,M,\varepsilon} X^{1-\varepsilon/2}.$$

Proof. Applying Hölder's inequality gives

$$\sum_{\substack{X \leq n \leq MX \\ (n, 2N)=1}} |c(f, n)|^2 \mu^2(n) \leq \left(\sum_{\substack{X \leq n \leq MX \\ (n, 2N)=1}} |c(f, n)| \mu^2(n) \right)^{2/3} \left(\sum_{\substack{X \leq n \leq MX \\ (n, 2N)=1}} |c(f, n)|^4 \mu^2(n) \right)^{1/3}.$$

Hence, using Proposition 2.3 we conclude that

$$(20) \quad \sum_{\substack{X \leq n \leq MX \\ (n, 2N)=1}} |c(f, n)| \mu^2(n) \gg_{f, M, \varepsilon} X^{1-\varepsilon/2}.$$

Also, by (14) we have that

$$\sum_{\substack{X \leq n \leq MX \\ (n, 2N)=1 \\ |c(f, n)| > X^\varepsilon}} |c(f, n)| \mu^2(n) < X^{-\varepsilon} \sum_{\substack{X \leq n \leq MX \\ (n, 2N)=1}} |c(f, n)|^2 \mu^2(n) \ll_{f, M, \varepsilon} X^{1-\varepsilon}.$$

Combining this with (20) completes the proof. \square

Proof of Proposition 3.2. Let $C(f, n) = |c(f, n)| \mu^2(n) 1_{(n, 2N)=1} 1_{|c(f, n)| \leq X^\varepsilon}$. Applying Lemma 3.4

$$X^{1-\varepsilon/2} \ll_{f, M, \varepsilon} \sum_{X+y \leq n \leq 2MX} C(f, n) \leq \frac{1}{y} \sum_{X \leq x \leq 2MX} \sum_{x \leq n \leq x+y} C(f, n),$$

where the inequality above follows since every term in the sum on the l.h.s. is counted $[y] + 1$ times on the r.h.s.. Let $S = \{X \leq x \leq 2MX : \sum_{x \leq n \leq x+y} C(f, n) \leq y/X^\varepsilon\}$. The contribution to the r.h.s. from the integers $x \in S$ is $\ll_{f, M, \varepsilon} \frac{1}{y} \cdot X \frac{y}{X^\varepsilon} = X^{1-\varepsilon}$. Hence we must have that

$$X^{1-\varepsilon/2} \ll_{f, M, \varepsilon} \frac{1}{y} \sum_{\substack{X \leq x \leq 2MX \\ x \notin S}} \sum_{x \leq n \leq x+y} C(f, n) \ll_{f, M, \varepsilon} \frac{1}{y} \cdot y X^\varepsilon \sum_{\substack{X \leq x \leq 2MX \\ x \notin S}} 1,$$

so that $\#\{X \leq x \leq 2MX : x \notin S\} \gg_{f, M, \varepsilon} X^{1-\frac{3}{2}\varepsilon}$. \square

3.3. Proof of Proposition 3.3. Throughout this section we write

$$(21) \quad W(u) = u^{\frac{k-1/2}{2}} e^{-2\pi u}.$$

The proof of the proposition proceeds directly, beginning with an application of Cauchy-Schwarz. This leads naturally to a shifted convolution sum of Fourier coefficients of f over squarefree integers and to bound this sum we require the following fairly standard result.

Proposition 3.5. *Let $f \in S_{k+\frac{1}{2}}^+(4N)$. Then for $1 \leq r \leq X^{\frac{1}{102}}$, $0 < |h| < X^{\frac{1}{2}}$, and $v \in \mathbb{Z}$ with $(v, r) = 1$ we have for any given $\varepsilon > 0$ that*

$$(22) \quad \sum_{n \geq 1} c(f, n) c(f, n+h) e\left(\frac{nv}{r}\right) W\left(\frac{n}{X}\right) W\left(\frac{n+h}{X}\right) \ll_{f, \varepsilon} X^{1-\frac{1}{102}+\varepsilon}.$$

Proof. This is an extension of Proposition 6.1 of [LR19] to the case of general level and below we will describe how to adapt the arguments given there to this case. The initial step is to use the Fourier expansion of f to express the l.h.s. of (22) as

$$= \frac{1}{X^{k-\frac{1}{2}}} \int_0^1 f\left(\alpha + \frac{v}{q} + \frac{i}{X}\right) f\left(-\alpha + \frac{i}{X}\right) e(-\alpha h) d\alpha.$$

We now use the circle method following Jutila [Jut92], as in [Har03, Proposition 2]. An important feature in Jutila's version of the circle method is that we have freedom over our choice of moduli, which we choose as follows

$$\mathcal{Q} = \{Q \leq q \leq 2Q : q = 4Nrp \text{ and } p \equiv 1 \pmod{4} \text{ is prime}\}.$$

Write $R = \sum_{q \in \mathcal{Q}} \varphi(q)$. Upon applying [Har03, Proposition 2] with $\delta = Q^{-2+\eta}$, $Q = X^{1/2+2\eta}$, $r \leq X^{\eta/8}$, where $\eta > 0$ is chosen later, we get that up to a error term of size $O_f(X^{1-\eta/8+\varepsilon})$ the above integral equals

$$(23) \quad \frac{Q^{2-\eta}}{2RX^{k-\frac{1}{2}}} \sum_{q \in \mathcal{Q}} \sum_{d \pmod{q}}^* e\left(-\frac{hd}{q}\right) \int_{-\delta}^{\delta} f\left(\frac{d}{q} + \frac{v}{r} + \alpha + \frac{i}{X}\right) f\left(\frac{-d}{q} - \alpha + \frac{i}{X}\right) e(-\alpha h) d\alpha.$$

Notably, to estimate the error term we use that $y^{\frac{k}{2}+\frac{1}{4}}|f(z)|$ is bounded on \mathbb{H} , since f is a cusp form.

Since we have chosen our moduli $q \in \mathcal{Q}$ so that $4N|q$ we are able to use the modularity of f by applying [LR19, Lemma 6.1], which extends to general level in straightforward way, then once again use the Fourier expansion of f . Consequently, we have transformed the original sum on the l.h.s. of (22), which is effectively over $n \leq X^{1+\varepsilon}$, to dual sums which are effectively over $m, n \leq X^\varepsilon Q^2/X$. The summands in the dual sums include the Fourier coefficients of f twisted by additive characters and factors from the half-integral weight multiplier system along with a Kloosterman sum $S(\star, -h; p)$, where the first argument, \star , depends on N, p, m, n, v, r . An important observation is that since p is a prime with $0 < |h| < p$, the Weil bound gives $|S(\star, -h; p)| \leq 2\sqrt{p}$ for any $\star \in \mathbb{Z}$. Using the Weil bound and estimating the dual sums over m, n by applying Cauchy-Schwarz and (16) to handle the Fourier coefficients of f we can show that (23) is bounded by

$$\ll_{f,\varepsilon} X^{3/4+49\eta/16+\varepsilon}.$$

Recalling our earlier error term of $O(X^{1-\eta/8+\varepsilon})$, which arose from applying Jutila's circle method we now take $\eta = 4/51$ to complete the proof. \square

To sum over squarefree integers we will sieve out integers that have a square divisor and require the following estimate for sums of Fourier coefficients.

Lemma 3.6. *Let $f \in S_{k+\frac{1}{2}}^+(4N)$. Then*

$$\sum_{\substack{n \leq X \\ (n, 2N)=1 \\ d^2|n}} |c(f, n)| \ll_{f,\varepsilon} \frac{X^{1+\varepsilon}}{d^2}.$$

Proof. Just as in the proof of Proposition 2.3, using (13) it suffices to consider the case $f = f_1|U(r^2)$, where $f_1 \in S_{k+\frac{1}{2}}^{+,\text{new}}(4\ell)$ is a newform with $r\ell|N$. For $(n, 2N) = 1$ write $n = s^2m$ where m is odd and squarefree. Also, let $t = rs$ and note $(t, \ell) = 1$ since N is squarefree. Applying Lemma 2.1 we have that

$$c(f_1|U(r^2), n) = c(f_1, t^2m) \ll_{\varepsilon} t^{\varepsilon} |c(f_1, m)|.$$

Using this bound then applying Cauchy-Schwarz and (16) we get that

$$\sum_{\substack{n \leq X \\ (n, 2N)=1 \\ d^2|n}} |c(f_1|U(r^2), n)| \ll_{\varepsilon} X^{\varepsilon} \sum_{t \leq \sqrt{X}} \sum_{\substack{m \leq \frac{X}{t^2} \\ d|t}} |c(f_1, m)| \ll_{f,\varepsilon} X^{\varepsilon} \sum_{t \leq \sqrt{X}} \frac{X}{t^2} \ll_{\varepsilon} \frac{X^{1+\varepsilon}}{d^2}.$$

\square

Proof of Proposition 3.3. To handle the condition that $2n$ is squarefree we first recall that the indicator function of squarefree numbers is $\mu^2(n) = \sum_{d^2|n} \mu(d)$. We then treat the cases of divisors $d \leq Y$ and $d > Y$ separately, and let

$$\mu_{\leq Y}^2(n) = \sum_{\substack{d^2|n \\ d \leq Y}} \mu(d), \quad \mu_{> Y}^2(n) = \sum_{\substack{d^2|n \\ d > Y}} \mu(d).$$

First we consider the large divisors and get that

$$\sum_{X \leq x \leq 2X} \left| \sum_{\substack{x \leq n \leq x+y \\ (n, 2N)=1}} c(f, n) \mu_{> Y}^2(n) \right| \leq y \sum_{\substack{n \leq 4X \\ (n, 2N)=1}} |c(f, n) \mu_{> Y}^2(n)|.$$

Using the definition of $\mu_{> Y}^2(n)$ and applying Lemma 3.6 we see that the r.h.s. above is

$$(24) \quad \ll y \sum_{d > Y} \sum_{\substack{n \leq 4X \\ d^2|n}} |c(f, n)| \ll_{f, \varepsilon} y X^{1+\varepsilon} \sum_{d > Y} \frac{1}{d^2} \ll y \frac{X^{1+\varepsilon}}{Y}.$$

For $Y \geq \sqrt{y} X^\varepsilon$ this is $\ll X \sqrt{y}$, as needed.

Next, we will consider the contribution from the small divisors $d \leq Y$. Let $\tilde{C}(f, n) = c(f, n) \mu_{\leq Y}^2(n) 1_{(n, 2N)=1}$. Applying Cauchy-Schwarz and using that $W(u)^2 \gg 1$, for any $u \in [1, 2]$ we get

$$\begin{aligned} \sum_{X \leq x \leq 2X} \left| \sum_{x \leq n \leq x+y} \tilde{C}(f, n) \right| &\leq \sqrt{X} \left(\sum_{X \leq x \leq 2X} \left| \sum_{x \leq n \leq x+y} \tilde{C}(f, n) \right|^2 \right)^{1/2} \\ &\ll \sqrt{X} \left(\sum_{x \geq 1} \left| \sum_{x \leq n \leq x+y} \tilde{C}(f, n) \right|^2 W\left(\frac{x}{X}\right)^2 \right)^{1/2}. \end{aligned}$$

Assume $y \leq X^{1/4}$. We use the convention that $c(f, n) = 0$ if $n \notin \mathbb{N}$. To estimate the inner sums on the r.h.s. we expand the square, combine appropriate terms, use that W is a smooth function, and apply (16) to get that the r.h.s. above equals

$$\begin{aligned} &= \sum_{0 \leq h_1, h_2 \leq y} \sum_{n \geq 1} \tilde{C}(f, n+h_1) \tilde{C}(f, n+h_2) W\left(\frac{n}{X}\right)^2 \\ (25) \quad &= \sum_{|h| \leq y} \sum_{n \geq 1} \tilde{C}(f, n) \tilde{C}(f, n+h) W\left(\frac{n}{X}\right) W\left(\frac{n+h}{X}\right) \sum_{\substack{0 \leq h_1, h_2 \leq y \\ h_2 - h_1 = h}} \left(1 + O\left(\frac{y}{n} + \frac{y}{X}\right)\right) + O_f(1) \\ &= \sum_{|h| \leq y} (y+1-|h|) \sum_{n \geq 1} \tilde{C}(f, n) \tilde{C}(f, n+h) W\left(\frac{n}{X}\right) W\left(\frac{n+h}{X}\right) + O_{f, \varepsilon}(y^3 X^\varepsilon), \end{aligned}$$

Using (16) once again we get that the term with $h = 0$ in the sum on the r.h.s. above contributes

$$(26) \quad \ll y \sum_{n \geq 1} |c(f, n)|^2 W\left(\frac{n}{X}\right)^2 \ll_{f, \varepsilon} y X.$$

We will next estimate the contribution from the terms in (25) with $h \neq 0$. Recalling the definition of $\mu_{\leq Y}^2$ and using that

$$1_{(n, 2N)=1} = \sum_{d|(n, 2N)} \mu(d) = \sum_{\substack{d|2N \\ d|n}} \mu(d),$$

it follows that the contribution to the r.h.s. of (25) from the terms with $h \neq 0$ is

$$(27) \quad \ll y \sum_{\substack{0 < |h| \leq y \\ d_1, d_2 \leq Y \\ d_3, d_4 | 2N}} \left| \sum_{\substack{d_1^2 | n, d_2^2 | n+h \\ d_3 | n, d_4 | n+h}} c(f, n) c(f, n+h) W\left(\frac{n}{X}\right) W\left(\frac{n+h}{X}\right) \right|.$$

For n with $d_1^2 | n$, $d_2^2 | n+h$, $d_3 | n$, $d_4 | n+h$ we have $n \equiv a \pmod{r}$ for some $a, r \in \mathbb{Z}$ with $r \leq 16N^2Y^4$. Using additive characters to detect this congruence, we get that the inner sum above is

$$\begin{aligned} &= \sum_{n \equiv a \pmod{r}} c(f, n) c(f, n+h) W\left(\frac{n}{X}\right) W\left(\frac{n+h}{X}\right) \\ &= \frac{1}{r} \sum_{0 \leq v < r} e\left(\frac{-av}{r}\right) \sum_{n \geq 1} c(f, n) c(f, n+h) e\left(\frac{nv}{r}\right) W\left(\frac{n}{X}\right) W\left(\frac{n+h}{X}\right). \end{aligned}$$

For $v \neq 0$ write $v/r = v'/r'$ with $(r', v') = 1$ and if $v = 0$ we set $r' = 1$. Applying Proposition 3.5, we get that the sum above is $\ll_{f, \varepsilon} X^{1 - \frac{1}{102} + \varepsilon}$ provided that $r' \leq X^{\frac{1}{102}}$ and $0 < |h| < X^{\frac{1}{2}}$. Hence, by this along with (26) we conclude that for $16N^2Y^4 \leq X^{\frac{1}{102}}$ that the r.h.s. of (25) is $\ll_{f, \varepsilon} yX + y^2Y^2X^{1 - \frac{1}{102} + \varepsilon} + y^3X^\varepsilon$, which is $\ll yX$, as needed, provided that $y \leq X^{1/4}$ and

$$(28) \quad yY^2X^\varepsilon \ll X^{\frac{1}{102}}.$$

It remains to optimize our parameters. Recall that to handle the contribution of the small divisors we required $Y \geq \sqrt{y}X^\varepsilon$. We now choose $Y = \sqrt{y}X^\varepsilon$. Taking the constraint (28) into account the largest we can choose y is $y = X^{\frac{1}{204} - \frac{3}{2}\varepsilon}$. We conclude by noting that with these choices we have $16N^2Y^4 \ll_N X^{\frac{1}{102} - 3\varepsilon} \leq X^{\frac{1}{102}}$ as required for the application of Proposition 3.5. \square

4. LARGE VALUES FOR COEFFICIENTS OF HALF-INTEGRAL WEIGHT FORMS

The main result of this section, Theorem 4.1 below, generalizes [GKS20, Theorem 1] (which treated the case $N = 1$).

4.1. Statement of main result.

Theorem 4.1. *Let $k \geq 2$ be an integer, $N \geq 1$ be odd and squarefree, and $h \in S_{k+\frac{1}{2}}^+(4N)$ be a cusp form. Let $\varepsilon > 0$ be fixed. Then for all X sufficiently large, there exist at least $X^{1-\varepsilon}$ odd squarefree integers n coprime to N such that $X \leq n \leq 2X$ and*

$$|c(h, n)| \geq \exp\left(\frac{1}{82} \sqrt{\frac{\log n}{\log \log n}}\right).$$

We will prove this theorem by combining methods of [GKS20] and [RS15, LR19]. Our first job is to reduce the question to bounding central values of L -functions. This is done by using the explicit form of Waldspurger's formula due to Kohnen (Proposition 2.2 above).

4.2. Reduction to bounds on L -values. Fix an integer $k \geq 2$ and an odd squarefree integer $N \geq 1$ throughout Section 4. Let h be as in Theorem 4.1. We use the basis (13) to write

$$h = \sum_{\substack{r, \ell \geq 1 \\ r\ell | N}} \sum_{f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}} \alpha_{r, \ell, f} f|U(r^2),$$

where the coefficients $\alpha_{r,\ell,f}$ depend only on r, ℓ, f , and h . For each odd squarefree n , we use Lemma 2.1 to get the following identity for the Fourier coefficients:

$$c(h, n) = \sum_{\ell|N} \sum_{f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}} c(f, n) \sum_{r|\frac{N}{\ell}} \alpha_{r,\ell,f} \prod_{p|r} \left(\lambda_f(p) - \frac{1}{\sqrt{p}} \left(\frac{(-1)^k n}{p} \right) \right).$$

We already know that $c(h, n) \neq 0$ for some odd squarefree n (this follows from [SS13] for example). So we can (and will) fix $\ell_0|N$, $f_0 \in \mathcal{B}_{k+\frac{1}{2}, 4\ell_0}^{\text{new}}$, and a reduced residue class $\eta \pmod{4N}$ such that

$$\begin{aligned} \eta &\equiv 1 \pmod{4}, \quad \left(\frac{\eta}{p} \right) = w_p \quad \text{for each } p|\ell_0, \\ \sum_{r|\frac{N}{\ell_0}} \alpha_{r,\ell_0,f_0} \prod_{p|r} \left(\lambda_{f_0}(p) - \frac{1}{\sqrt{p}} \left(\frac{\eta}{p} \right) \right) &\neq 0. \end{aligned}$$

Above, w_p is the eigenvalue of the Atkin-Lehner operator W_p acting on f_0 . For brevity, we denote for each $f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}$

$$\beta_f = \sum_{r|\frac{N}{\ell}} \alpha_{r,\ell,f} \prod_{p|r} \left(\lambda_f(p) - \frac{1}{\sqrt{p}} \left(\frac{\eta}{p} \right) \right).$$

We will denote the Shimura lift of $f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}$ by $g_f \in S_{2k}^{\text{new}}(\ell)$ with Fourier coefficients $m^{k-\frac{1}{2}} \lambda_{g_f}(m)$ normalized so that $\lambda_{g_f}(1) = 1$. Also, write g_0 for g_{f_0} and $m^{k-\frac{1}{2}} \lambda_0(m)$ for its Fourier coefficients. For each odd squarefree integer n such that $d = (-1)^k n \equiv \eta \pmod{4N}$, we use the triangle inequality, Cauchy-Schwarz, and Proposition 2.2 to obtain

$$\begin{aligned} |c(h, n)| &= \left| \sum_{\ell|N} \sum_{f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}} c(f, n) \beta_f \right| \\ (29) \quad &\geq |\beta_{f_0} c_{f_0}(n)| - \sqrt{\left(\sum_{\ell|N} \sum_{f_0 \neq f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}} |c(f, n)|^2 \right) \left(\sum_{\ell|N} \sum_{f_0 \neq f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}} |\beta_f|^2 \right)} \\ &\geq A \sqrt{L\left(\frac{1}{2}, g_0 \otimes \chi_d\right)} - B \sqrt{\sum_{\ell|N} \sum_{f_0 \neq f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}} L\left(\frac{1}{2}, g_f \otimes \chi_d\right)}, \end{aligned}$$

where $A > 0$ and $B > 0$ are independent of d . Now, Theorem 4.1 follows from the following auxiliary result.

Proposition 4.2. *Let $C \geq 0$ be a constant, $\varepsilon > 0$, and let $\eta \pmod{4N}$ be a fixed reduced residue class with $\eta \equiv 1 \pmod{4}$. Given $\ell_0|N$ let $f_0 \in \mathcal{B}_{k+\frac{1}{2}, 4\ell_0}^{\text{new}}$ be a newform as above with Shimura lift g_0 . For sufficiently large X , there are $\geq X^{1-\varepsilon}$ odd squarefree integers $n \in [X, 2X]$, such that $d = (-1)^k n \equiv \eta \pmod{4N}$ and*

$$(30) \quad L\left(\frac{1}{2}, g_0 \otimes \chi_d\right) > C \sum_{\ell|N} \sum_{\substack{f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}} \\ (\ell, f) \neq (\ell_0, f_0)}} L\left(\frac{1}{2}, g_f \otimes \chi_d\right) + \exp\left(\frac{1}{40} \sqrt{\frac{\log X}{\log \log X}}\right).$$

We first explain how Proposition 4.2 implies Theorem 4.1. Put $L_0 = L\left(\frac{1}{2}, g_0 \otimes \chi_d\right)$ and $L_1 = \sum_{\ell|N} \sum_{f_0 \neq f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}} L\left(\frac{1}{2}, g_f \otimes \chi_d\right)$. Put $C = 2B^2/A^2$. Combining Proposition 4.2 and (29),

$$|c(h, n)| \geq A\sqrt{L_0} - B\sqrt{L_1} > A\sqrt{CL_1 + \exp\left(\frac{1}{40} \sqrt{\frac{\log X}{\log \log X}}\right)} - B\sqrt{L_1}$$

$$\begin{aligned}
&\geq \frac{A}{\sqrt{2}} \left(\sqrt{CL_1} + \exp \left(\frac{1}{80} \sqrt{\frac{\log X}{\log \log X}} \right) \right) - B\sqrt{L_1} \\
&= \frac{A}{\sqrt{2}} \exp \left(\frac{1}{80} \sqrt{\frac{\log X}{\log \log X}} \right) \geq \exp \left(\frac{1}{82} \sqrt{\frac{\log n}{\log \log n}} \right)
\end{aligned}$$

for sufficiently large X . We now proceed with the proof of Proposition 4.2. For $\eta \equiv 1 \pmod{4}$, let

$$\mathcal{D}_{N,\eta} = \{d = (-1)^k n : \mu^2(2n) \neq 0, (n, N) = 1, d \equiv \eta \pmod{4N}\}$$

and

$$\mathcal{D}_{N,\eta}(X) = \mathcal{D}_{N,\eta} \cap [X, 2X].$$

For each such d we introduce a resonance polynomial

$$R(d) = \sum_{m \leq M} r(m) \lambda_0(m) \chi_d(m),$$

where the coefficients $r(m)$ are multiplicative and supported on squarefree integers. At primes we set

$$r(p) = \begin{cases} \frac{L}{\sqrt{p} \log p} & \text{if } L^2 \leq p \leq L^4 \text{ and } p \nmid N \\ 0 & \text{otherwise} \end{cases}$$

where $L = \frac{1}{8} \sqrt{\log M \log \log M}$ with $M = X^{1/24}$.

The strategy to prove (30) is to consider the quantity

$$\sum_{d \in \mathcal{D}_{N,\eta}(X)} L \left(\frac{1}{2}, g_0 \otimes \chi_d \right) |R(d)|^2.$$

Let \mathcal{S} be the subset of $\mathcal{D}_{N,\eta}(X)$ for which the estimate (30) holds. Then certainly

$$\begin{aligned}
&\sum_{d \in \mathcal{D}_{N,\eta}(X)} L \left(\frac{1}{2}, g_0 \otimes \chi_d \right) |R(d)|^2 \\
&\leq \sum_{d \in \mathcal{D}_{N,\eta}(X)} \left(\sum_{\substack{\ell=1 \\ \ell|N}}^{\infty} \sum_{\substack{f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}} \\ (\ell, f) \neq (\ell_0, f_0)}} CL \left(\frac{1}{2}, g_f \otimes \chi_d \right) + \exp \left(\frac{1}{40} \sqrt{\frac{\log X}{\log \log X}} \right) \right) |R(d)|^2 \\
&\quad + \sum_{d \in \mathcal{S}} L \left(\frac{1}{2}, g_0 \otimes \chi_d \right) |R(d)|^2.
\end{aligned}$$

Suppose that the following estimates hold:

$$(31) \quad \sum_{d \in \mathcal{D}_{N,\eta}(X)} L \left(\frac{1}{2}, g_0 \otimes \chi_d \right) |R(d)|^2 \gg_{k,N} X \cdot \mathcal{R} \cdot \exp \left(\left(\frac{1}{2} + o(1) \right) \frac{L}{\log L} \right),$$

$$(32) \quad \sum_{d \in \mathcal{D}_{N,\eta}(X)} L \left(\frac{1}{2}, g_f \otimes \chi_d \right) |R(d)|^2 \ll_{k,N} X \cdot \mathcal{R} \cdot \exp \left(o \left(\frac{L}{\log L} \right) \right) \quad \text{for } f \neq f_0,$$

$$(33) \quad \sum_{d \in \mathcal{D}_{N,\eta}(X)} |R(d)|^2 \leq \frac{2X}{\pi^2} \cdot \mathcal{R} + O(X),$$

$$(34) \quad \sum_{d \in \mathcal{D}_{N,\eta}(X)} |R(d)|^6 \ll X \cdot \exp \left(O \left(\frac{\log X}{\log \log X} \right) \right),$$

where

$$\mathcal{R} = \prod_{L^2 \leq p \leq L^4} (1 + r(p)^2 \lambda_0(p)^2).$$

Assuming (31)-(34) the proof of Proposition 4.2 can be finished as follows. We observe that

$$\begin{aligned} X \cdot \mathcal{R} \cdot \exp\left(\left(\frac{1}{2} + o(1)\right) \frac{L}{\log L}\right) &\ll_{k,N} \sum_{d \in \mathcal{D}_{N,\eta}(X)} L\left(\frac{1}{2}, g_0 \otimes \chi_d\right) |R(d)|^2 \\ &\ll_{k,N} X \cdot \mathcal{R} \cdot \exp\left(o\left(\frac{L}{\log L}\right)\right) + \sum_{d \in \mathcal{S}} L\left(\frac{1}{2}, g_0 \otimes \chi_d\right) |R(d)|^2 \end{aligned}$$

by using (31), (32) and (33). Hence,

$$(35) \quad X \cdot \mathcal{R} \cdot \exp\left(\left(\frac{1}{2} + o(1)\right) \frac{L}{\log L}\right) \ll_{k,N} \sum_{d \in \mathcal{S}} L\left(\frac{1}{2}, g_0 \otimes \chi_d\right) |R(d)|^2.$$

On the other hand, r.h.s of the previous display can be estimated by Hölder's inequality and (34) as

$$\begin{aligned} &\leq \left(\sum_{d \in \mathcal{D}_{N,\eta}(X)} L\left(\frac{1}{2}, g_0 \otimes \chi_d\right)^2 \right)^{1/2} \cdot |\mathcal{S}|^{1/6} \left(\sum_{d \in \mathcal{S}} |R(d)|^6 \right)^{1/3} \\ &\ll_{k,N} X^{1/2+\varepsilon/2} |\mathcal{S}|^{1/6} \cdot \left(X \cdot \exp\left(O\left(\frac{\log X}{\log \log X}\right)\right) \right)^{1/3}, \end{aligned}$$

where the average of the squares of central L -values is estimated by the result of Perelli and Pomykala [PPa97]. Combining this with (35) gives $|\mathcal{S}| \gg_{k,N} X^{1-\varepsilon/2} \geq X^{1-\varepsilon}$, as desired.

So it suffices to establish estimates (31)-(34). Notice that (33) and (34) follow directly from Proposition 3 of [GKS20] by simply estimating

$$\sum_{d \in \mathcal{D}_{N,\eta}(X)} |R(d)|^2 \leq \sum_{\substack{X \leq (-1)^k d \leq 2X \\ d \equiv 1 \pmod{4}}} |R(d)|^2 \quad \text{and} \quad \sum_{d \in \mathcal{D}_{N,\eta}(X)} |R(d)|^6 \leq \sum_{\substack{X \leq (-1)^k d \leq 2X \\ d \equiv 1 \pmod{4}}} |R(d)|^6.$$

The other two estimates are consequences of the following first moment result.

Proposition 4.3. *Let $N \geq 1$ be a positive integer and $g \in S_{2k}^{\text{new}}(\ell)$ for some $\ell|N$. Suppose that u is an odd positive integer coprime to N and write $u = u_1 u_2^2$ with u_1 squarefree. Let Φ denote a smooth and compactly supported function in $[1/2, 5/2]$. Then*

$$\begin{aligned} &\sum_{d \in \mathcal{D}_{N,\eta}} L\left(\frac{1}{2}, g \otimes \chi_d\right) \chi_d(u) \Phi\left(\frac{|d|}{X}\right) \\ &= \frac{X \lambda_g(u_1)}{2N u_1^{1/2}} \left(\int_0^\infty \Phi(\xi) d\xi \right) L_{g,\eta}\left(\frac{1}{2}\right) L\left(1, \text{Sym}^2 g\right) \mathcal{G}(1; u) + O_{k,N,\Phi,\varepsilon}\left(X^{7/8+\varepsilon} u^{3/8+\varepsilon}\right). \end{aligned}$$

Here $L_{g,\eta}(1/2) \neq 0$ is the Dirichlet series given in (36) and $\mathcal{G}(1; u)$ is the Euler product defined in (42). Furthermore, $\mathcal{G}(1; \cdot)$ is a multiplicative function satisfying $\mathcal{G}(1; p^k) = 1 + O(1/p)$ at prime powers.

4.3. A twisted first moment asymptotic. In this subsection, we prove Proposition 4.3. The starting point is the approximate functional equation (which follows by an easy modification of the proof of Lemma 5 in [RS15]) saying that

$$L\left(\frac{1}{2}, g \otimes \chi_d\right) = 2 \sum_{\substack{m=1 \\ (m, 2N)=1}}^{\infty} \frac{\lambda_g(m) \chi_d(m)}{\sqrt{m}} W_{g,\eta}\left(\frac{m}{|d|}\right),$$

where $W_{g,\eta}$ is a smooth weight function defined by, for $c > 1/2$,

(36)

$$W_{g,\eta}(\xi) = \frac{1}{2\pi i} \int_{(c)} L_{g,\eta}\left(s + \frac{1}{2}\right) \frac{\Gamma(s+k)}{\Gamma(k)} \left(\frac{\sqrt{\ell}}{2\pi\xi}\right)^s \frac{ds}{s}, \quad L_{g,\eta}(s) = \sum_{\substack{m=1 \\ p|m \Rightarrow p|2N}}^{\infty} \frac{\lambda_g(m) \chi_d(m)}{m^s}.$$

Notice that the value of $L_{g,\eta}(s)$ is the same for each $d \equiv \eta \pmod{4N}$. The weight function satisfies $W_{g,\eta}(\xi) = L_{g,\eta}(1/2) + O_{k,N,\varepsilon}(\xi^{\frac{1}{2}-\varepsilon})$ as $\xi \rightarrow 0$ and $W_{g,\eta}(\xi) \ll_{k,N,A} |\xi|^{-A}$ for any $A \geq 1$ as $\xi \rightarrow \infty$. Thus the sum we have to evaluate takes the shape

$$2 \sum_{\substack{m=1 \\ (m, 2N)=1}}^{\infty} \frac{\lambda_g(m)}{\sqrt{m}} \sum_{d \in \mathcal{D}_{N,\eta}} \chi_d(mu) W_{g,\eta}\left(\frac{m}{|d|}\right) \Phi\left(\frac{|d|}{X}\right).$$

Notice that by definition any $d \in \mathcal{D}_{N,\eta}$ is squarefree and odd. We pick out this property by the identity

$$(37) \quad \sum_{\substack{\alpha=1 \\ (\alpha, 2N)=1 \\ \alpha^2|d}}^{\infty} \mu(\alpha) = \begin{cases} 1 & \text{if } d \text{ is squarefree} \\ 0 & \text{otherwise} \end{cases}$$

Note that the above identity holds without the condition $(\alpha, 2N) = 1$, but this can be added as by construction $(d, 2N) = 1$ for $d \in \mathcal{D}_{N,\eta}$. Inserting this to the above expression gives that the d -sum is given by

$$\begin{aligned} & \sum_{d \in \mathcal{D}_{N,\eta}} \sum_{\substack{\alpha=1 \\ (\alpha, 2N)=1 \\ \alpha^2|d}}^{\infty} \mu(\alpha) \chi_d(mu) W_{g,\eta}\left(\frac{m}{|d|}\right) \Phi\left(\frac{|d|}{X}\right) \\ &= \sum_{\substack{\alpha=1 \\ (\alpha, 2Nu)=1}}^{\infty} \mu(\alpha) \left(\frac{\alpha^2}{mu}\right) \sum_{r \equiv \eta \alpha^2 \pmod{4N}} \left(\frac{r}{mu}\right) W_{g,\eta}\left(\frac{m}{r\alpha^2}\right) \Phi\left(\frac{r\alpha^2}{X}\right). \end{aligned}$$

Let $Y \geq 1$ be a parameter to be chosen later. By splitting the α -sum into parts depending on whether $1 \leq \alpha \leq \sqrt{Y}$ or $\alpha > \sqrt{Y}$ we get

$$\begin{aligned} & 2 \sum_{\substack{m=1 \\ (m, 2N)=1}}^{\infty} \frac{\lambda_g(m)}{\sqrt{m}} \sum_{d \in \mathcal{D}_{N,\eta}} \chi_d(mu) W_{g,\eta}\left(\frac{m}{|d|}\right) \Phi\left(\frac{|d|}{X}\right) \\ &= 2 \sum_{\substack{m=1 \\ (m, 2N)=1}}^{\infty} \frac{\lambda_g(m)}{\sqrt{m}} \left(\sum_{\substack{1 \leq \alpha \leq \sqrt{Y} \\ (\alpha, 2Nu)=1}} + \sum_{\substack{\alpha > \sqrt{Y} \\ (\alpha, 2Nu)=1}} \right) \mu(\alpha) \left(\frac{\alpha^2}{mu}\right) \\ & \quad \cdot \sum_{r \equiv \eta \alpha^2 \pmod{4N}} \left(\frac{r}{mu}\right) W_{g,\eta}\left(\frac{m}{r\alpha^2}\right) \Phi\left(\frac{r\alpha^2}{X}\right). \end{aligned}$$

Let us first focus on the part where $\alpha > \sqrt{Y}$. Estimating by the triangle inequality and using the definition of the weight function $W_{g,\eta}$, this contribution is bounded by

$$\sum_{\substack{\alpha > \sqrt{Y} \\ (\alpha, 2N)=1}} \sum_{r \equiv \eta \alpha^2 \pmod{4N}} \left| \Phi \left(\frac{r^2 \alpha}{X} \right) \right| \left| \int_{(c)} \frac{\Gamma(s+k)}{\Gamma(k)} \left(\frac{\sqrt{\ell} \alpha^2 r}{2\pi} \right)^s L_{g,\eta} \left(s + \frac{1}{2} \right) \cdot \frac{L(s+\frac{1}{2}, g \otimes \chi_{r\alpha^2})}{\prod_{p|2N} L_p(s+\frac{1}{2}, g \otimes \chi_{r\alpha^2})} \frac{ds}{s} \right|$$

for $c > 1/2$.

Writing $r\alpha^2 = k_1 k_2^2$ with k_1 a fundamental discriminant implies $\alpha | k_2$. We can then replace $L(1/2 + s, g \otimes \chi_{k_1 k_2^2})$ in the integrand by $L(1/2 + s, g \otimes \chi_{k_1})$ up to local Euler factors corresponding to primes dividing k_2 . This, together with trivial estimation, shows that the integrand extends as an analytic function to the domain $1/\log X \leq \operatorname{Re}(s) \leq 3/2$. As in [LR19, Section 5.2], by shifting the line of integration to the line $\operatorname{Re}(s) = 1/\log X$, using Stirling's formula, and recalling that $k_1 k_2^2 \leq X$, the sum above is

$$\ll_{k,N,\Phi} X^\varepsilon \sum_{\alpha > \sqrt{Y}} \sum_{\substack{\infty \\ \alpha | k_2}}^{k_2=1} \sum_{|k_1| \leq \frac{X^{1+\varepsilon}}{k_2^2}}^b \int_{(1/\log X)} e^{-|s|} \left| L \left(s + \frac{1}{2}, g \otimes \chi_{k_1} \right) \right| ds,$$

where in the innermost sum \sum^b indicates the sum over the fundamental discriminants. Applying the approximate functional equation, Heath-Brown's quadratic large sieve [HB95], and the Cauchy-Schwarz inequality this can be further bounded by $\ll_{k,N,\varepsilon} X^{1+\varepsilon}/\sqrt{Y}$ (for the details, see [LR19, Section 5.2]).

Let us then turn to the part where $1 \leq \alpha \leq \sqrt{Y}$. Here the idea is to apply the Poisson summation formula to the r -sum. To state the relevant form of the summation formula, let us define, for any $j \in \mathbb{Z}$, a Gauss-type sum

$$(38) \quad \tau_j(n) = \sum_{b \pmod{n}} \left(\frac{n}{b} \right) e \left(\frac{jb}{n} \right) = \left(\frac{1+i}{2} + \left(\frac{-1}{n} \right) \frac{(1-i)}{2} \right) G_j(n),$$

where

$$G_j(n) = \left(\frac{1-i}{2} + \left(\frac{-1}{n} \right) \frac{(1+i)}{2} \right) \sum_{a \pmod{n}} \left(\frac{n}{a} \right) e \left(\frac{aj}{n} \right).$$

It can be shown that for odd coprime m, n one has $G_j(mn) = G_j(m)G_j(n)$ and if $p^\alpha || j$ for a prime p , then the exact formula for $G_j(p^\beta)$ is given in [Sou00, Lemma 2.3] in terms of the relative sizes of α and β . The Poisson summation formula needed for our purposes is contained in the following lemma.

Lemma 4.4. ([RS15, Lemma 7]) *Let n be an odd integer and q positive integer so that $(n, q) = 1$. Suppose that F is a smooth and compactly supported function on \mathbb{R} . Finally, let η be a reduced residue class modulo q . Then*

$$\sum_{d \equiv \eta \pmod{q}} \left(\frac{d}{n} \right) F(d) = \frac{1}{qn} \left(\frac{q}{n} \right) \sum_{j \in \mathbb{Z}} \widehat{F} \left(\frac{j}{nq} \right) e \left(\frac{j\eta\bar{n}}{q} \right) \tau_j(n),$$

where

$$\widehat{F}(u) = \int_{\mathbb{R}} F(x) e(-xu) dx.$$

Set $F(x; y, z) = \Phi(x/y) W_{g,\eta}(z/x)$ for simplicity. By Lemma 4.4 we have

$$(39) \quad \begin{aligned} & \sum_{r \equiv \eta \alpha^2 \pmod{4N}} \left(\frac{r}{m\alpha} \right) W_{g,\eta} \left(\frac{m}{r\alpha^2} \right) \Phi \left(\frac{r\alpha^2}{X} \right) \\ &= \frac{1}{4N m \alpha} \left(\frac{4N}{m\alpha} \right) \sum_{j \in \mathbb{Z}} \widehat{F} \left(\frac{j}{4N m \alpha}; \frac{X}{\alpha^2}, \frac{m}{\alpha^2} \right) e \left(\frac{j\eta \overline{4N m \alpha}}{4N} \right) \tau_j(m\alpha). \end{aligned}$$

Let us first analyze the total contribution coming from the term $j = 0$ to the m -sum. As

$$\tau_0(mu) = \begin{cases} \varphi(mu), & \text{if } mu \text{ is a square} \\ 0, & \text{otherwise} \end{cases}$$

this is given by

$$\frac{1}{4N} \sum_{\substack{1 \leq \alpha^2 \leq Y \\ (\alpha, 2Nu)=1}} \mu(\alpha) \sum_{\substack{m=1 \\ (m, 2N\alpha)=1 \\ mu \text{ is a square}}}^{\infty} \frac{\lambda_g(m)}{\sqrt{m}} \cdot \frac{\varphi(mu)}{mu} \left(\frac{4N}{mu} \right) \widehat{F} \left(0; \frac{X}{\alpha^2}, \frac{m}{\alpha^2} \right).$$

The terms $\alpha > \sqrt{Y}$ can be added back with a contribution $\ll_{k,N,\Phi,\varepsilon} X^{1+\varepsilon}/\sqrt{Y}$ as in [RS15, Section 7]. By definition of the weight function $W_{g,\eta}$ it follows, again for $c > 1/2$, that

$$\widehat{F} \left(0; \frac{X}{\alpha^2}, \frac{m}{\alpha^2} \right) = \frac{X}{\alpha^2} \cdot \frac{1}{2\pi i} \int_{(c)} L_{g,\eta} \left(s + \frac{1}{2} \right) \frac{\Gamma(s+k)}{\Gamma(k)} \left(\frac{\sqrt{\ell}X}{2\pi m} \right)^s \left(\int_0^\infty \Phi(\xi) \xi^s d\xi \right) \frac{ds}{s}.$$

So the contribution in the r.h.s of (39) from $j = 0$ is

$$(40) \quad \frac{X}{2N} \cdot \frac{1}{2\pi i} \int_{(c)} \left(\int_0^\infty \Phi(\xi) \xi^s d\xi \right) L_{g,\eta} \left(s + \frac{1}{2} \right) \frac{\Gamma(s+k)}{\Gamma(k)} \left(\frac{\sqrt{\ell}X}{2\pi} \right)^s \\ \cdot \sum_{\substack{\alpha=1 \\ (\alpha, 2Nu)=1}}^{\infty} \frac{\mu(\alpha)}{\alpha^2} \sum_{\substack{m=1 \\ (m, 2N\alpha)=1 \\ mu \text{ is a square}}}^{\infty} \frac{\lambda_g(m)}{m^{s+1/2}} \cdot \frac{\varphi(mu)}{mu} \frac{ds}{s} + O_{k,N,\Phi,\varepsilon} \left(\frac{X^{1+\varepsilon}}{\sqrt{Y}} \right).$$

A simple computation shows that, for $(m, 2N) = 1$,

$$\sum_{\substack{\alpha=1 \\ (\alpha, 2N\alpha)=1}}^{\infty} \frac{\mu(\alpha)}{\alpha^2} \cdot \frac{\varphi(mu)}{mu} = \prod_{p|2N} \left(1 - \frac{1}{p^2} \right) \prod_{p|um} \left(1 + \frac{1}{p} \right)^{-1}, \quad \text{leading to}$$

$$(41) \quad \sum_{\substack{\alpha=1 \\ (\alpha, 2Nu)=1}}^{\infty} \frac{\mu(\alpha)}{\alpha^2} \sum_{\substack{m=1 \\ (m, 2N\alpha)=1 \\ mu \text{ is a square}}}^{\infty} \frac{\lambda_g(m)}{m^{s+1/2}} \cdot \frac{\varphi(mu)}{mu} = \prod_{p|2N} \left(1 - \frac{1}{p^2} \right) \sum_{\substack{m=1 \\ (m, 2N)=1 \\ mu \text{ is a square}}}^{\infty} \frac{\lambda_g(m)}{m^{s+1/2}} \prod_{p|um} \left(1 + \frac{1}{p} \right)^{-1}.$$

For mu a square and $u = u_1 u_2^2$ with u_1 squarefree, it follows that $m = u_1 \ell^2$ for some $\ell \in \mathbb{Z}$. Hence the r.h.s of the previous display is

$$\prod_{p|2N} \left(1 - \frac{1}{p^2} \right) \sum_{\substack{\ell=1 \\ (\ell, 2N)=1}}^{\infty} \frac{\lambda_g(u_1 \ell^2)}{u_1^{s+1/2} \ell^{2s+1}} \prod_{p|u\ell} \left(1 + \frac{1}{p} \right)^{-1} \\ = \frac{1}{u_1^{s+1/2}} \prod_{p|2N} \left(1 - \frac{1}{p^2} \right) \prod_{p|2Nu} \left(1 + \sum_{k=1}^{\infty} \frac{\lambda_g(p^{2k})}{p^{k(2s+1)}} \left(1 + \frac{1}{p} \right)^{-1} \right) \prod_{p|u} \left(\sum_{k=0}^{\infty} \frac{\lambda_g(p^{2k+\text{ord}_p(u_1)})}{p^{k(2s+1)}} \right) \left(1 + \frac{1}{p} \right)^{-1} \\ = \frac{1}{u_1^{s+1/2}} L(2s+1, \text{Sym}^2 g) \prod_{p|2N} L_p(2s+1, \text{Sym}^2 h)^{-1} \prod_{p|u} \left(1 - \frac{1}{p} \right) \left(\sum_{k=0}^{\infty} \frac{\lambda_g(p^{2k+\text{ord}_p(u_1)})}{p^{k(2s+1)}} \right) \\ \cdot L_p(2s+1, \text{Sym}^2 g)^{-1} \prod_{p|2Nu} \left(1 - \frac{1}{p^2} \right) \left(1 + \sum_{k=1}^{\infty} \frac{\lambda_g(p^{2k})}{p^{k(2s+1)}} \left(1 + \frac{1}{p} \right)^{-1} \right) L_p(2s+1, \text{Sym}^2 g)^{-1}.$$

From this it is easy to see, by using the Euler product expression of the symmetric square L -function, that for $p \nmid 2Nu$ the corresponding Euler factor is

$$= \left(1 - \frac{1}{p}\right) \left(1 - \frac{1}{p^{2s+1}}\right) \left(\frac{1}{p} \left(1 - \frac{\alpha_p^2}{p^{2s+1}}\right) \left(1 - \frac{\beta_p^2}{p^{2s+1}}\right) + 1 + \frac{1}{p^{2s+1}}\right),$$

where $\{\alpha_p, \beta_p\}$ are the Satake parameters of the cusp form g at p .

Similarly, for $p|u$, $p \nmid u_1$, the corresponding Euler factor is $\left(1 - \frac{1}{p}\right) \left(1 - \frac{1}{p^{4s+2}}\right)$. For $p|u_1$, the corresponding Euler factor is $\left(1 - \frac{1}{p}\right) \left(1 - \frac{1}{p^{2s+1}}\right) \lambda_g(p)$ by using the relations $\lambda_g(p^j) = (\alpha_p^{j+1} - \beta_p^{j+1})/(\alpha_p - \beta_p)$ for $j \geq 0$ and $\alpha_p \beta_p = 1$. And finally, for $p|2N$ the corresponding Euler factor is clearly $L_p(2s+1, \text{Sym}^2 g)^{-1}$.

To summarize, the r.h.s of (41) equals

$$\frac{\lambda_g(u_1)}{u_1^{s+1/2}} L(2s+1, \text{Sym}^2 g) \mathcal{G}(2s+1; u),$$

where $\mathcal{G}(2s+1; u) = \prod_p \mathcal{G}_p(2s+1; u)$ is the Euler product locally given by

(42)

$$\mathcal{G}_p(2s+1; u) = \begin{cases} L_p(2s+1, \text{Sym}^2 g)^{-1} & \text{if } p|2N \\ \left(1 - \frac{1}{p}\right) \left(1 - \frac{1}{p^{2s+1}}\right) & \text{if } p|u_1 \\ \left(1 - \frac{1}{p}\right) \left(1 - \frac{1}{p^{4s+2}}\right) & \text{if } p|u_2, p \nmid u_1 \\ \left(1 - \frac{1}{p}\right) \left(1 - \frac{1}{p^{2s+1}}\right) \left(1 + \frac{1}{p} \left(1 - \frac{\alpha_p^2}{p^{2s+1}}\right) \left(1 - \frac{\beta_p^2}{p^{2s+1}}\right) + \frac{1}{p^{2s+1}}\right) & \text{if } p \nmid 2Nu. \end{cases}$$

By estimating trivially it follows that $\mathcal{G}(2s+1; u)$ extends analytically to the domain $\text{Re}(s) > -1/4$ and is bounded there by

$$\ll \prod_{p|2Nu} \left(1 + \frac{O(1)}{\sqrt{p}}\right) \ll_{N,\varepsilon} u^\varepsilon.$$

Consequently the s -integrand in (40) extends to an analytic function in the above domain (apart from a simple pole at $s = 0$). Thus moving the line of integration in (40) to the line $\text{Re}(s) = -1/4 + \varepsilon$ shows that the term corresponding to the value of $j = 0$ equals

$$\frac{X \lambda_g(u_1)}{2Nu_1^{1/2}} \left(\int_0^\infty \Phi(\xi) d\xi\right) L_{g,\eta}\left(\frac{1}{2}\right) L(1, \text{Sym}^2 g) \mathcal{G}(1; u) + O_{k,N,\Phi,\varepsilon}(X^{3/4+\varepsilon}) + O_{k,N,\Phi,\varepsilon}\left(\frac{X^{1+\varepsilon}}{\sqrt{Y}}\right),$$

where the main terms comes from the residue at $s = 0$ and the first error term from the contour shift. It follows immediately from the definition of $\mathcal{G}(s; u)$ that $\mathcal{G}(1; \cdot)$ is multiplicative and that $\mathcal{G}(1; p^k) = 1 + O(1/p)$ at prime powers.

It remains to bound the contribution coming from the other terms (i.e. $j \neq 0$) in (39). By the triangle inequality this contribution is bounded by

$$\ll_N \frac{1}{u} \sum_{\substack{1 \leq \alpha \leq \sqrt{Y} \\ (\alpha, 2N)=1}} \left| \sum_{j \neq 0} \sum_{\substack{m=1 \\ (m, 2N\alpha)=1}}^\infty \frac{\lambda_g(m)}{m^{3/2}} \left(\frac{\alpha^2}{m}\right) \widehat{F}\left(\frac{j}{4Nmu}; \frac{X}{\alpha^2}, \frac{m}{\alpha^2}\right) \tau_j(mu) e\left(\frac{j\eta\overline{\alpha^2 mu}}{4N}\right) \right|.$$

For $j \neq 0$, we have, by using [LR19, Lemma 5.3.],

$$\widehat{F}\left(\frac{j}{4Nmu}; \frac{X}{\alpha^2}, \frac{m}{\alpha^2}\right) \ll_{k,N,\Phi,A} \frac{X}{\alpha^2} \min\left(\left(\frac{N\alpha^2 u}{|j|}\right)^A, \left(\frac{X}{m}\right)^A\right)$$

for any integer $A \geq 1$. By choosing A to be large enough the above bound shows that the terms where $|j| > 4NuYX^\varepsilon$ contribute $\ll_{k,N,\Phi} X^{-1}$ (see [LR19, Eq'n (5.24)]). For the remaining terms

$1 \leq |j| \leq NuYX^\varepsilon$ we replace the additive character by a weighted average of Dirichlet characters modulo $4N$ by using orthogonality relations, which reduces the matter to estimating

$$(43) \quad \sum_{\psi \pmod{4N}} \left| \sum_{\substack{m=1 \\ (m, 2N)=1}}^{\infty} \frac{\lambda_g(m)}{m^{3/2}} \left(\frac{\alpha^2}{m} \right) \psi(m) \tau_j(mu) \widehat{F} \left(\frac{j}{4Nmu}; \frac{X}{\alpha^2}, \frac{m}{\alpha^2} \right) \right|.$$

For $\operatorname{Re}(s) > 0$ let us define the Mellin transform

$$\begin{aligned} \widetilde{F}(s; j, \alpha^2) &= \int_0^\infty \widehat{F} \left(\frac{j}{4Ntu}; \frac{X}{\alpha^2}, \frac{t}{\alpha^2} \right) t^{s-1} dt \\ &= \frac{X^{s+1}}{\alpha^2} \left(\int_0^\infty \Phi(\xi) \xi^s d\xi \right) \int_0^\infty W_{g,\eta} \left(\frac{1}{y} \right) e \left(-\frac{ jy }{4Nu\alpha^2} \right) \frac{dy}{y^{s+1}}. \end{aligned}$$

By the Mellin inversion the m -sum inside the absolute values in (43) equals

$$(44) \quad \frac{1}{2\pi i} \int_{(c)} \widetilde{F}(s; j, \alpha^2) \sum_{\substack{m=1 \\ (m, 2N)=1}}^{\infty} \frac{\lambda_g(m)}{m^{3/2+s}} \left(\frac{\alpha^2}{m} \right) \psi(m) \tau_j(mu) ds.$$

Now, as $W_{g,\eta}(\xi) = L_{g,\eta}(1/2) + O_{k,N}(\xi^{\frac{1}{2}-\varepsilon})$ as $\xi \rightarrow 0$, it follows that $\widetilde{F}(s; j, \alpha^2)$ continues analytically to the half-plane $\operatorname{Re}(s) \geq -1/2 + \varepsilon$ and satisfies there an estimate $\ll_{k,N,\Phi,A} X^{1+\operatorname{Re}(s)}/\alpha^2(1+|s|)^A$, for any $A \geq 1$, (see [LR19, Lemma 5.4.]). By using the identity (38) and the properties of $G_j(m)$, a similar Euler product calculation used to compute the main term shows that the m -sum in (44) is, up to a constant, equal to

$$L(1+s, g \otimes \chi_j \psi) \prod_p R_p(s, u, j, \alpha, N),$$

where the local Euler factors satisfy

$$|R_p(s, u, j, \alpha, N)| \leq \begin{cases} 1 + O\left(\frac{1}{p^{1+\varepsilon}}\right) & \text{if } p \nmid 2Nju\alpha \\ u \left(1 + O\left(\frac{1}{p^\varepsilon}\right)\right) & \text{if } p|ju\alpha, p \nmid 2N \\ 1 + O\left(\frac{1}{p^{1/2+\varepsilon}}\right) & \text{if } p|2N \end{cases}$$

for $\operatorname{Re}(s) \geq -1/2 + \varepsilon$. Therefore

$$\prod_p R_p(s, u, j, \alpha, N) \ll u \prod_{p|2ujN\alpha} \left(1 + \frac{O(1)}{p^\varepsilon}\right) \ll_{N,\varepsilon} uX^\varepsilon$$

for $\operatorname{Re}(s) \geq -1/2 + \varepsilon$. Hence, the Euler product is absolutely convergent in the half-plane $\operatorname{Re}(s) \geq -1/2 + \varepsilon$ and thus defines an analytic function there. This gives, by shifting the line of integration in (44) to the line $\operatorname{Re}(s) = -1/2 + \varepsilon$, the bound

$$\ll_{k,N,\Phi,\varepsilon} \frac{X^{1/2+\varepsilon}}{\alpha^2} \cdot u|j|^{1/2+\varepsilon}$$

for (44) by using the convexity bound $L(1/2 + \varepsilon + it, g \otimes \chi_j \psi) \ll_{k,N,\varepsilon} (1+|t|)^{1/2+\varepsilon}|j|^{1/2+\varepsilon}$ [IK04, Chapter 5] and the bound for \widetilde{F} mentioned above. Thus, the contribution to (39) from the terms corresponding to $1 \leq |j| \leq 4NuYX^\varepsilon$ is

$$\begin{aligned} &\ll_{k,N,\Phi,\varepsilon} \frac{1}{u} \cdot u \cdot X^{1/2+\varepsilon} \sum_{1 \leq \alpha \leq \sqrt{Y}} \frac{1}{\alpha^2} \sum_{1 \leq |j| \leq 4NuYX^\varepsilon} |j|^{1/2+\varepsilon} \\ &\ll_{k,N,\Phi,\varepsilon} X^{1/2+\varepsilon} u^{3/2+\varepsilon} Y^{3/2+\varepsilon}. \end{aligned}$$

So altogether the total contribution coming from the terms where $j \neq 0$ is

$$\ll_{k,N,\Phi,\varepsilon} u^{3/2+\varepsilon} Y^{3/2+\varepsilon} X^{1/2+\varepsilon} + X^{-1} \ll_{k,N,\Phi,\varepsilon} u^{3/2+\varepsilon} Y^{3/2+\varepsilon} X^{1/2+\varepsilon}.$$

This is $\ll_{k,N,\Phi,\varepsilon} X^{7/8+\varepsilon} u^{3/8+\varepsilon}$ by choosing $Y = X^{1/4} u^{-3/4}$. The other error terms are at most $\ll_{k,N,\Phi,\varepsilon} X^{7/8+\varepsilon} u^{3/8+\varepsilon}$ with this choice of Y , concluding the proof of Proposition 4.3.

4.4. Proofs of the estimates. We are now ready to prove the estimates (31) and (32). As the arguments are similar to [GKS20], we will be brief. Let us denote

$$A_{g,\eta}(\Phi) = \frac{1}{2N} \left(\int_0^\infty \Phi(\xi) d\xi \right) L_{g,\eta} \left(\frac{1}{2} \right) L \left(1, \text{Sym}^2 g \right)$$

and

$$B_g(u) = \frac{\lambda_g(u_1)}{u_1^{1/2}} \mathfrak{G}(1; u)$$

for $u = u_1 u_2^2$ with u_1 squarefree.

Let Φ be a compactly supported smooth weight function. Our aim is now to evaluate

$$\sum_{d \in \mathcal{D}_{N,\eta}} L \left(\frac{1}{2}, g \otimes \chi_d \right) |R(d)|^2 \Phi \left(\frac{|d|}{X} \right)$$

for $g = g_f \in S_{2k}^{\text{new}}(\ell)$, where $f \in \mathcal{B}_{k+\frac{1}{2},4\ell}^{\text{new}}$ with $\ell|N$, by choosing Φ appropriately for given f .

By opening the definition of $R(d)$ and using Proposition 4.3 the above sum equals

$$\begin{aligned} & \sum_{d \in \mathcal{D}_{N,\eta}} L \left(\frac{1}{2}, g \otimes \chi_d \right) \Phi \left(\frac{|d|}{X} \right) \sum_{n_1, n_2 \leq M} r(n_1) r(n_2) \lambda_0(n_1) \lambda_0(n_2) \chi_d(n_1 n_2) \\ &= X \cdot A_{g,\eta}(\Phi) \sum_{n_1, n_2 \leq M} r(n_1) r(n_2) \lambda_0(n_1) \lambda_0(n_2) B_g(n_1 n_2) \\ & \quad + O_{k,N,\Phi,\varepsilon} \left(X^{7/8+\varepsilon} \sum_{n_1, n_2 \leq M} r(n_1) r(n_2) |\lambda_0(n_1) \lambda_0(n_2)| (n_1 n_2)^{3/8+\varepsilon} \right) \end{aligned}$$

as $r(n)$ vanishes unless $(n, N) = 1$. By using Deligne's bound we obtain as in [GKS20, §6] that the error term is $\ll_{k,N,\Phi} X^{99/100}$.

By making use of the fact that

$$n_1 n_2 = \frac{n_1 n_2}{(n_1, n_2)^2} \cdot (n_1, n_2)^2,$$

with the first factor on the r.h.s squarefree in our case as the function $r(n)$ is supported only on squarefree integers, the main term can be written as

$$X \cdot A_{g,\eta}(\Phi) \sum_{n_1, n_2 \leq M} r(n_1) r(n_2) \lambda_0(n_1) \lambda_0(n_2) \frac{\lambda_g \left(\frac{n_1 n_2}{(n_1, n_2)^2} \right)}{\left(\frac{n_1 n_2}{(n_1, n_2)^2} \right)^{1/2}} \cdot \mathfrak{G}(1; n_1 n_2).$$

Our aim is to use multiplicativity and so we need to extend the sum over all integers. To do so we must show that the terms with $\max(n_1, n_2) > M$ can be added with a tolerable error. By using Rankin's trick these terms contribute

$$\begin{aligned} & \ll_{k,N} X \sum_{\max(n_1, n_2) > M} r(n_1) r(n_2) |\lambda_0(n_1) \lambda_0(n_2)| \cdot |\mathfrak{G}(1; n_1 n_2)| \cdot \left| \frac{\lambda_g \left(\frac{n_1 n_2}{(n_1, n_2)^2} \right)}{\left(\frac{n_1 n_2}{(n_1, n_2)^2} \right)^{1/2}} \right| \\ & \ll_{k,N} X \sum_{n_1, n_2=1}^{\infty} r(n_1) r(n_2) |\lambda_0(n_1) \lambda_0(n_2)| \cdot |\mathfrak{G}(1; n_1 n_2)| \cdot \left| \frac{\lambda_g \left(\frac{n_1 n_2}{(n_1, n_2)^2} \right)}{\left(\frac{n_1 n_2}{(n_1, n_2)^2} \right)^{1/2}} \right| \left(\frac{n_1 n_2}{M} \right)^\alpha \end{aligned}$$

for any $\alpha > 0$, which is chosen optimally later.

Write $n = n_1 n_2$ to express the double sum above as a single sum over n and note that by the fact that $r(\cdot)$ is supported only on squarefree integers coprime to N the only integers n which contribute to the sum over n satisfy $p^3 \nmid n$ and $(n, N) = 1$. Hence, by multiplicativity of $r(\cdot)$ we can express the sum over n as an Euler product and the expression on the r.h.s of the previous display equals

$$\begin{aligned} &= XM^{-\alpha} \prod_{L^2 \leq p \leq L^4} \left(1 + 2r(p)p^{\alpha-1/2} |\mathcal{G}(1; p)| \cdot \frac{|\lambda_0(p)\lambda_g(p)|}{\sqrt{p}} + r(p)^2 p^{2\alpha} |\mathcal{G}(1; p^2)| \cdot |\lambda_0(p)|^2 \right) \\ &\ll XM^{-\alpha} \exp \left(\sum_{L^2 \leq p \leq L^4} \left(\frac{8Lp^{\alpha-1}}{\log p} + \frac{4L^2 p^{2\alpha-1}}{(\log p)^2} \right) \left(1 + O\left(\frac{1}{p}\right) \right) \right), \end{aligned}$$

where the last estimate follows from Deligne's bound $|\lambda_g(p)| \leq 2$, the fact that $\mathcal{G}(1; p^k) = 1 + O(1/p)$, and the definition of $r(n)$.

Let us now choose $\alpha = 1/(8 \log L)$. Then by the prime number theorem and partial summation the above is

$$\ll X \cdot \exp \left(-\frac{\log M}{8 \log L} + \frac{8L}{\log L} + \frac{4L^2}{(\log L)^2} \right) \ll X$$

by the choices $L = \frac{1}{8} \sqrt{\log M \log \log M}$ and $M = X^{1/24}$. From the above arguments we deduce that

$$\begin{aligned} &\sum_{d \in \mathcal{D}_{N, \eta}} L \left(\frac{1}{2}, g \otimes \chi_d \right) |R(d)|^2 \Phi \left(\frac{|d|}{X} \right) \\ &= A_{g, \eta}(\Phi) \cdot X \cdot \prod_{L^2 \leq p \leq L^4} \left(1 + 2r(p) \mathcal{G}(1; p) \cdot \frac{\lambda_0(p)\lambda_g(p)}{\sqrt{p}} + r(p)^2 \mathcal{G}(1; p^2) \cdot \lambda_0(p)^2 \right) + O_{k, N, \Phi}(X) \\ (45) \quad &= A_{g, \eta}(\Phi) \cdot X \cdot \mathcal{R} \cdot \exp \left(2 \sum_{L^2 \leq p \leq L^4} \frac{r(p)\lambda_0(p)\lambda_g(p)}{\sqrt{p}} + O_{k, N, \Phi} \left(\frac{L}{(\log L)^3} \right) \right) + O_{k, N, \Phi}(X), \end{aligned}$$

where the last step follows exactly as in [GKS20, §6].

We now apply this result with $g = g_f$, where $f \in \mathcal{B}_{k+\frac{1}{2}, 4\ell}^{\text{new}}$ with $\ell | N$. For (31) we choose Φ to be supported on the interval $[1, 2]$ so that $\Phi(t) = 1$ for $t \in [11/10, 19/10]$ and satisfying $0 \leq \Phi(t) \leq 1$. For (32) we choose Φ to be supported in $[1/2, 5/2]$ with $\Phi(t) = 1$ for $t \in [1, 2]$ and again and satisfying $0 \leq \Phi(t) \leq 1$. These choices lead to

$$\begin{aligned} &\sum_{d \in \mathcal{D}_{N, \eta}(X)} L \left(\frac{1}{2}, g_0 \otimes \chi_d \right) |R(d)|^2 \\ &\geq \frac{4X\mathcal{R}}{5N} \cdot L_{g_0, \eta} \left(\frac{1}{2} \right) L \left(1, \text{Sym}^2 g_0 \right) \cdot \exp \left(2 \sum_{L^2 \leq p \leq L^4} \frac{r(p)\lambda_0(p)^2}{\sqrt{p}} + O \left(\frac{L}{(\log L)^3} \right) \right) + O_{k, N}(X) \end{aligned}$$

for $f = f_0$, and

$$\begin{aligned} &\sum_{d \in \mathcal{D}_{N, \eta}(X)} L \left(\frac{1}{2}, g_f \otimes \chi_d \right) |R(d)|^2 \\ &\leq \frac{X\mathcal{R}}{N} \cdot L_{g_f, \eta} \left(\frac{1}{2} \right) L \left(1, \text{Sym}^2 g_f \right) \exp \left(2 \sum_{L^2 \leq p \leq L^4} \frac{r(p)\lambda_0(p)\lambda_{g_f}(p)}{\sqrt{p}} + O \left(\frac{L}{(\log L)^3} \right) \right) + O_{k, N}(X) \end{aligned}$$

for $f \neq f_0$.

To obtain (31) and (32) we use partial summation and the following estimate, which is a consequence of the Rankin-Selberg theory [WY07, Theorem 3]:

Lemma 4.5. *With the notation above we have*

$$\sum_{p \leq x} \lambda_0(p)\lambda_{g_f}(p) \log p = x \cdot 1_{f=f_0} + o(x).$$

5. SIEGEL CUSP FORMS OF DEGREE 2

In this Section we first review various properties of Siegel cusp forms of degree 2 and then go on to prove our main results stated in the introduction.

5.1. **Preliminaries.** Denote by J the 4 by 4 matrix given by $J = \begin{pmatrix} 0 & I_2 \\ -I_2 & 0 \end{pmatrix}$ where I_2 is the identity matrix of size 2. Define the algebraic groups GSp_4 and Sp_4 over \mathbb{Z} by

$$\mathrm{GSp}_4(R) = \{g \in \mathrm{GL}_4(R) \mid {}^t g J g = \mu_2(g) J, \mu_2(g) \in R^\times\},$$

$$\mathrm{Sp}_4(R) = \{g \in \mathrm{GSp}_4(R) \mid \mu_2(g) = 1\},$$

for any commutative ring R . The Siegel upper-half space \mathbb{H}_2 of degree 2 is defined by

$$\mathbb{H}_2 = \{Z \in \mathrm{Mat}_{2 \times 2}(\mathbb{C}) \mid Z = {}^t Z, \mathrm{Im}(Z) \text{ is positive definite}\}.$$

Let k and N be positive integers. Let $\Gamma_0^{(2)}(N) \subseteq \mathrm{Sp}_4(\mathbb{Z})$ denote the Siegel congruence subgroup of level N , i.e.,

$$(46) \quad \Gamma_0^{(2)}(N) = \mathrm{Sp}_4(\mathbb{Z}) \cap \begin{pmatrix} \mathbb{Z} & \mathbb{Z} & \mathbb{Z} & \mathbb{Z} \\ \mathbb{Z} & \mathbb{Z} & \mathbb{Z} & \mathbb{Z} \\ N\mathbb{Z} & N\mathbb{Z} & \mathbb{Z} & \mathbb{Z} \\ N\mathbb{Z} & N\mathbb{Z} & \mathbb{Z} & \mathbb{Z} \end{pmatrix}.$$

We define

$$g\langle Z \rangle = (AZ + B)(CZ + D)^{-1} \quad \text{for } g = \begin{pmatrix} A & B \\ C & D \end{pmatrix} \in \mathrm{Sp}_4(\mathbb{R}), Z \in \mathbb{H}_2.$$

We let $J(g, Z) = CZ + D$. Let $S_k(\Gamma_0^{(2)}(N))$ denote the space of Siegel cusp forms of weight k and level N ; precisely, they consist of the holomorphic functions F on \mathbb{H}_2 which satisfy the relation

$$(47) \quad F(\gamma\langle Z \rangle) = \det(J(\gamma, Z))^k F(Z)$$

for $\gamma \in \Gamma_0^{(2)}(N)$, $Z \in \mathbb{H}_2$, and vanish at all the cusps. Any F in $S_k(\Gamma_0^{(2)}(N))$ has a Fourier expansion

$$(48) \quad F(Z) = \sum_{S \in \Lambda_2} a(F, S) e^{2\pi i \mathrm{Tr}(SZ)}$$

with Λ_2 defined in (2). We have the relation

$$(49) \quad a(F, T) = \det(A)^k a(F, {}^t A T A)$$

for $A \in \mathrm{GL}_2(\mathbb{Z})$. In particular, the Fourier coefficient $a(F, T)$ depends only on the $\mathrm{SL}_2(\mathbb{Z})$ -equivalence class of T . We say that a matrix $S \in \Lambda_2$ is fundamental if $\mathrm{disc}(S) = -4 \det(S)$ is a fundamental discriminant. Given a fundamental discriminant $d < 0$ and $K = \mathbb{Q}(\sqrt{d})$, let Cl_K denote the ideal class group of K . It is well-known that the $\mathrm{SL}_2(\mathbb{Z})$ -equivalence classes of matrices in Λ_2 of discriminant d can be identified with Cl_K ; so the expression $\sum_{S \in \mathrm{Cl}_K} a(F, S) \Lambda(S)$ makes sense for each $\Lambda \in \widehat{\mathrm{Cl}_K}$.

5.2. **Constructing half-integral weight forms.** Each F in $S_k(\Gamma_0^{(2)}(N))$ has a Fourier–Jacobi expansion $F(Z) = \sum_{m > 0} \phi_m(\tau, z) e^{2\pi i m \tau'}$ where we write $Z = \begin{pmatrix} \tau & z \\ z & \tau' \end{pmatrix}$ and for each $m > 0$,

$$(50) \quad \phi_m(\tau, z) = \sum_{\substack{n, r \in \mathbb{Z} \\ 4nm > r^2}} a \left(F, \begin{pmatrix} n & r/2 \\ r/2 & m \end{pmatrix} \right) e^{2\pi i(n\tau + rz)} \in J_{k, m}^{\mathrm{cusp}}(N).$$

Here $J_{k, m}^{\mathrm{cusp}}(N)$ denotes the space of Jacobi cusp forms of weight k , level N and index m .

Given a *primitive* matrix $S = \begin{pmatrix} a & b/2 \\ b/2 & c \end{pmatrix} \in \Lambda_2$ (i.e., $\mathrm{gcd}(a, b, c) = 1$) we let $\mathcal{P}(S)$ denote the set of primes of the form $ax^2 + bxy + cy^2$. The set $\mathcal{P}(S)$ is infinite; indeed by [Iwa74, Theorem 1 (i)],

$$(51) \quad |\{p \in \mathcal{P}(S) : p \leq X\}| \gg_S \frac{X}{\log X}.$$

For each prime p dividing N , define the operator $U(p)$ acting on the space $S_k(\Gamma_0^{(2)}(N))$ via

$$(52) \quad a(U(p)F, S) = a(F, pS).$$

Lemma 5.1. *Let $k > 2$ be even and N be squarefree. Let $F \in S_k(\Gamma_0^{(2)}(N))$ be an eigenfunction of the $U(p)$ operator for each prime $p|N$ (note that if $N = 1$, this condition is trivially true).*

- i) *Then there exists $S_0 = \begin{pmatrix} a & b/2 \\ b/2 & c \end{pmatrix} \in \Lambda_2$ such that $a(F, S_0) \neq 0$ and $d_0 = b^2 - 4ac$ is odd and squarefree (and hence, S_0 is fundamental).*
- ii) *Let S_0, d_0 be as above and let $p \nmid 2Nd_0$ be a prime such that $p \in \mathcal{P}(S_0)$. Put*

$$h_p(z) = \sum_{m=1}^{\infty} a(m)e^{2\pi imz}, \quad \text{where} \quad a(m) = \sum_{\substack{0 \leq \mu \leq 2p-1 \\ \mu^2 \equiv -m \pmod{4p}}} a \left(F, \begin{pmatrix} \frac{m+\mu^2}{4p} & \frac{\mu}{2} \\ \frac{\mu}{2} & p \end{pmatrix} \right).$$

Then $0 \neq h_p \in S_{k-\frac{1}{2}}^+(4pN)$. Furthermore, for each $m > 0$ such that $\gcd(m, 4p) = 1$,

$$(53) \quad a(m) = 2a \left(F, \begin{pmatrix} \frac{m+\mu_0^2}{4p} & \frac{\mu_0}{2} \\ \frac{\mu_0}{2} & p \end{pmatrix} \right)$$

where μ_0 is any integer satisfying $\mu_0^2 \equiv -m \pmod{4p}$; if no such μ_0 exists then $a(m) = 0$.

Proof. The claim that there exists $S_0 = \begin{pmatrix} a & b/2 \\ b/2 & c \end{pmatrix} \in \Lambda_2$ such that $a(F, S_0) \neq 0$ and $d_0 = b^2 - 4ac$ is odd and squarefree follows from Theorem 2.2 of [SS13].

Now let $p \in \mathcal{P}(S_0)$, $p \nmid 2Nd_0$. The fact that $h_p \in S_{k-\frac{1}{2}}(4pN)$ follows from $\phi_p \in J_{k,p}^{\text{cusp}}(N)$ and Theorem 4.8 of [MR00]; by definition h_p belongs to the Kohnen plus space. Next, we prove (53). Let $\gcd(m, 4p) = 1$. Observe that the sum $\sum_{\substack{0 \leq \mu \leq 2p-1 \\ \mu^2 \equiv -m \pmod{4p}}}$ is non-empty if and only if $-m$ is a square modulo $4p$ in which case the sum has exactly two terms. Indeed, we get that

$$(54) \quad a(m) = a \left(F, \begin{pmatrix} \frac{m+\mu_0^2}{4p} & \frac{\mu_0}{2} \\ \frac{\mu_0}{2} & p \end{pmatrix} \right) + a \left(F, \begin{pmatrix} \frac{m+\mu_1^2}{4p} & \frac{\mu_1}{2} \\ \frac{\mu_1}{2} & p \end{pmatrix} \right)$$

where $0 \leq \mu_0 \leq 2p - 1$ satisfies $\mu_0^2 \equiv -m \pmod{4p}$ and $\mu_1 = 2p - \mu_0$. Using (49), (54), and the identity $\begin{pmatrix} 1 & -1 \\ 0 & -1 \end{pmatrix} \begin{pmatrix} \frac{m+\mu_0^2}{4p} & \frac{\mu_0}{2} \\ \frac{\mu_0}{2} & p \end{pmatrix} \begin{pmatrix} 1 & 0 \\ -1 & -1 \end{pmatrix} = \begin{pmatrix} \frac{m+\mu_1^2}{4p} & \frac{\mu_1}{2} \\ \frac{\mu_1}{2} & p \end{pmatrix}$, we obtain (53).

It remains to show $h_p \neq 0$ for which we will show that $a(-d_0) \neq 0$. Let x_0, y_0 be integers such that $cx_0^2 + bx_0y_0 + ay_0^2 = p$. Since $\gcd(x_0, y_0) = 1$, we may pick integers x_1, y_1 such that $A = \begin{pmatrix} y_1 & y_0 \\ x_1 & x_0 \end{pmatrix} \in \text{SL}_2(\mathbb{Z})$. Then $S' = {}^tASA$ is $\text{SL}_2(\mathbb{Z})$ -equivalent to S_0 and has the form $S' = \begin{pmatrix} \frac{-d_0+\mu_0^2}{4p} & \frac{\mu_0}{2} \\ \frac{\mu_0}{2} & p \end{pmatrix} \in \Lambda_2$. By (49), $a(F, S') \neq 0$ since $a(F, S_0) \neq 0$. Hence by (53), $a(-d_0) = 2a(F, S') \neq 0$. \square

5.3. The proofs of Theorems A and B. We are now ready to prove Theorems A and B of the introduction in a slightly stronger form.

Theorem 5.2. *Let $F \in S_k(\Gamma_0^{(2)}(N))$ with $k > 2$ even and N odd and squarefree. Assume that F is an eigenfunction of the $U(p)$ operator for each prime $p|N$, and that F has real Fourier coefficients. Then there exists a set \mathcal{P} of primes satisfying $|\{p \in \mathcal{P} : p \leq X\}| \gg_F \frac{X}{\log X}$ such that given $\varepsilon > 0$ and $p \in \mathcal{P}$, there exist $M \geq 2$ (depending only on F and p) and $X_0 \geq 1$ (depending on F, p and ε) so that for all $X \geq X_0$, there are $r_X \geq X^{1-\varepsilon}$ matrices $S_1, S_2, \dots, S_{r_X} \in \Lambda_2$ satisfying the following:*

- i) $X \leq |\text{disc}(S_1)| < |\text{disc}(S_2)| < \dots < |\text{disc}(S_{r_X})| \leq MX$,

- ii) For each $1 \leq i \leq r_X$, $S_i = \begin{pmatrix} * & * \\ * & p \end{pmatrix}$, and $\text{disc}(S_i)$ is a squarefree integer coprime to $2N$,
- iii) For each $1 \leq i \leq r_X - 1$, $a(F, S_i)a(F, S_{i+1}) < 0$.

Proof. Using Lemma 5.1, we fix a fundamental matrix S_0 such that $a(F, S_0) \neq 0$. Take $\mathcal{P} = \mathcal{P}(S_0)$; then the estimate $|\{p \in \mathcal{P} : p \leq X\}| \gg \frac{X}{\log X}$ follows from (51). Given any $p \in \mathcal{P}$, let $f = h_p$ be as in Lemma 5.1, so that $0 \neq f \in S_{k-\frac{1}{2}}^+(4pN)$ and the coefficients of f are all real since the coefficients of F are.

By Theorem 3.1, there exists $M \geq 2$ such that for any $\varepsilon > 0$, the sequence $\{a(f, n)\mu^2(n)\}_{\substack{X \leq n \leq MX \\ (n, 2N)=1}}$ has $\geq C_{f, M, \varepsilon} X^{1-\varepsilon/2}$ sign changes for some constant $C_{f, M, \varepsilon}$. Pick $X_0 \geq 1$ so that for all $X \geq X_0$ we have $X^{\varepsilon/2} \geq \frac{1}{C_{f, M, \varepsilon}}$. Then for all $X \geq X_0$, there exists $r_X \geq X^{1-\varepsilon}$, and an increasing sequence $(n_i)_{1 \leq i \leq r_X}$ of odd squarefree integers satisfying $a(f, n_i)a(f, n_{i+1}) < 0$. For each n_i as above, (53) tells us that $a(f, n_i) = 2a(F, S_i)$ for some $S_i = \begin{pmatrix} * & * \\ * & p \end{pmatrix} \in \Lambda_2$ with $|\text{disc}(S_i)| = n_i$. This completes the proof. \square

Theorem 5.3. *Let $F \in S_k(\Gamma_0^{(2)}(N))$ with $k > 2$ even and N odd and squarefree. Assume that F is an eigenfunction of the $U(p)$ operator for each prime $p|N$. Then there exists a set \mathcal{P} of primes satisfying $|\{p \in \mathcal{P} : p \leq X\}| \gg_F \frac{X}{\log X}$ such that given $\varepsilon > 0$ and $p \in \mathcal{P}$, one can find $X_0 \geq 1$ (depending on F, p and ε) so that for all $X \geq X_0$, there are $r_X \geq X^{1-\varepsilon}$ matrices $S_1, S_2, \dots, S_{r_X} \in \Lambda_2$ satisfying the following:*

- i) For each $1 \leq i \leq r_X$, $S_i = \begin{pmatrix} * & * \\ * & p \end{pmatrix}$, and $\text{disc}(S_i)$ is a squarefree integer coprime to $2N$,
- ii) $X \leq |\text{disc}(S_1)| < |\text{disc}(S_2)| < \dots < |\text{disc}(S_{r_X})| \leq 2X$,
- iii) For each $1 \leq i \leq r_X$, $|a(F, S_i)| \geq |\text{disc}(S_i)|^{\frac{k-3}{2}} \exp\left(\frac{1}{82} \sqrt{\frac{\log |\text{disc}(S_i)|}{\log \log |\text{disc}(S_i)|}}\right)$.

Proof. The proof is essentially identical to Theorem 5.2, except that we use Theorem 4.1 (rather than Theorem 3.1) on $f = h_p$. \square

5.4. L -functions of Siegel cusp forms. For the rest of this section we assume that $k > 2$.

Given an irreducible cuspidal automorphic representation π of $\text{GSp}_4(\mathbb{A})$, we let $L(s, \pi)$ denote the associated degree 4 L -function (known as the “spin” L -function). Furthermore, we let $L(s, \text{std}(\pi))$ denote the associated degree 5 L -function (the “standard” L -function) and $L(s, \text{ad}(\pi))$ denote the associated degree 10 L -function (the “adjoint” L -function). Each of these L -functions is defined as an Euler product with the local L -factor at each prime (including the ramified primes) constructed via the associated representation of the dual group $\text{GSp}_4(\mathbb{C})$ using the local Langlands correspondence (which is known for GSp_4 by the work of Gan–Takeda [GT11]). More precisely, for $n = 4, 5, 10$, let ρ_n denote the irreducible n -dimensional representation of $\text{GSp}_4(\mathbb{C})$ given as follows: ρ_4 is the inclusion of $\text{GSp}_4(\mathbb{C}) \hookrightarrow \text{GL}_4(\mathbb{C})$, ρ_5 is the map defined in [RS07, A.7], and ρ_{10} is the adjoint representation of $\text{GSp}_4(\mathbb{C})$ on the Lie algebra of $\text{Sp}_4(\mathbb{C})$. Then $L(s, \pi)$, $L(s, \text{std}(\pi))$, and $L(s, \text{ad}(\pi))$ correspond to the representations ρ_4 , ρ_5 and ρ_{10} respectively.

We say that an element F of $S_k(\Gamma_0^{(2)}(N))$ gives rise to an irreducible representation if its adelization (in the sense of [Sah15, §3]) generates an irreducible cuspidal automorphic representation of $\text{GSp}_4(\mathbb{A})$. The automorphic representation associated to any such F is of trivial central character and hence may be viewed as an automorphic representation of $\text{PGSp}_4(\mathbb{A}) \simeq \text{SO}_5(\mathbb{A})$. It can be checked [Sah15, Prop. 3.11] that if F gives rise to an irreducible representation then F is an eigenform of the local Hecke algebras at all primes not dividing N . In addition, we say that such an F is factorizable if its adelization corresponds to a factorizable vector in the representation generated.

We say that an irreducible cuspidal automorphic representation π of $\mathrm{GSp}_4(\mathbb{A})$ *arises from* $S_k(\Gamma_0^{(2)}(N))$ if there exists $F \in S_k(\Gamma_0^{(2)}(N))$ whose adelization generates V_π (in which case, by definition, F gives rise to the irreducible representation π , which therefore must be of trivial central character by the comments above). We say that an irreducible cuspidal automorphic representation π of $\mathrm{GSp}_4(\mathbb{A})$ is CAP if it is nearly equivalent to a constituent of a global induced representation of a proper parabolic subgroup of $\mathrm{GSp}_4(\mathbb{A})$. If a CAP π arises from $S_k(\Gamma_0^{(2)}(N))$, then by Corollary 4.5 of [PS09b] it is associated to the Siegel parabolic (i.e., it is of *Saito-Kurokawa type*). Such a π is non-tempered at almost all primes (in particular, it violates the Ramanujan conjecture). On the other hand, if π arises from $S_k(\Gamma_0^{(2)}(N))$ and is *not* CAP, then π satisfies the Ramanujan conjecture by a famous result of Weissauer [Wei09, Thm. 3.3].

Thus, the space $S_k(\Gamma_0^{(2)}(N))$ has a natural decomposition into orthogonal subspaces

$$S_k(\Gamma_0^{(2)}(N)) = S_k(\Gamma_0^{(2)}(N))^{\mathrm{CAP}} \oplus S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$$

where $S_k(\Gamma_0^{(2)}(N))^{\mathrm{CAP}}$ is spanned by forms F which give rise to irreducible representations of Saito-Kurokawa type, and $S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$ is its orthogonal complement, spanned by forms F which give rise to irreducible representations that are not of Saito-Kurokawa type. Furthermore, one can get a basis of each of the spaces $S_k(\Gamma_0^{(2)}(N))^{\mathrm{CAP}}$ and $S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$ in terms of factorizable forms. We refer the reader to [DPSS20, §3.1 and §3.2] for further comments related to the above discussion.

If π arises from $S_k(\Gamma_0^{(2)}(N))$ and is of Saito-Kurokawa type, then there exists a representation π_0 of $\mathrm{GL}_2(\mathbb{A})$ and a Dirichlet character χ_0 satisfying $\chi_0^2 = 1$ such that $L^N(s, \pi) = L^N(s, \pi_0)L^N(s + 1/2, \chi_0)L^N(s - 1/2, \chi_0)$. Additionally, if N is squarefree, then only $\chi_0 = 1$ is possible by a well-known result of Borel [Bor76] and so in this case we have $L^N(s, \pi) = L^N(s, \pi_0)\zeta^N(s + 1/2)\zeta^N(s - 1/2)$. There exists another typical situation where the L -function factors: we say that a π arising from $S_k(\Gamma_0^{(2)}(N))$ is of *Yoshida type* if there are representations π_1 and π_2 of $\mathrm{GL}_2(\mathbb{A})$ such that $L(s, \pi) = L(s, \pi_1)L(s, \pi_2)$; in this case one has (after possibly swapping π_1 and π_2) that π_1 arises from a classical holomorphic newform of weight 2 and π_2 arises from a classical holomorphic newform of weight $2k - 2$ (see [Sah15, Sec. 4] for more details). We let $S_k(\Gamma_0^{(2)}(N))^{\mathrm{Y}}$ denote the subspace of $S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$ spanned by forms which give rise to an irreducible representation of Yoshida type, and let $S_k(\Gamma_0^{(2)}(N))^{\mathrm{G}}$, which represents the *general type*, denote the orthogonal complement of $S_k(\Gamma_0^{(2)}(N))^{\mathrm{Y}}$ in $S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$. So we get the following key orthogonal decomposition into subspaces

$$(55) \quad S_k(\Gamma_0^{(2)}(N)) = S_k(\Gamma_0^{(2)}(N))^{\mathrm{CAP}} \oplus S_k(\Gamma_0^{(2)}(N))^{\mathrm{Y}} \oplus S_k(\Gamma_0^{(2)}(N))^{\mathrm{G}}.$$

In the notation of [Sch18], the three subspaces on the right side above correspond to the *global Arthur packets* of type **(P)**, **(Y)** and **(G)** respectively. In the sequel we will be mostly concerned with the space $S_k(\Gamma_0^{(2)}(N))^{\mathrm{G}}$ because the other two spaces are easier to handle. The following proposition collects together some relevant facts about the associated L -functions that follow from the work of Arthur [Art13].

Proposition 5.4. *Suppose that $F \in S_k(\Gamma_0^{(2)}(N))^{\mathrm{G}}$ gives rise an irreducible representation π .*

- i) *The representation π has a strong functorial lifting to an irreducible cuspidal automorphic representation Π_4 of $\mathrm{GL}_4(\mathbb{A})$. In particular, if σ is any irreducible automorphic representation of $\mathrm{GL}_n(\mathbb{A})$, then we have an equality of degree $4n$ Rankin-Selberg L -functions*

$L(s, \pi \times \sigma) = L(s, \Pi_4 \times \sigma)$ and therefore $L(s, \pi \times \sigma)$ satisfies the usual properties⁵ of an L -function. If $n \leq 3$, then $L(s, \pi \times \sigma)$ is entire.

- ii) The representation π has a strong functorial lifting to an irreducible automorphic representation Π_5 of $\mathrm{GL}_5(\mathbb{A})$. In particular, if σ is any irreducible automorphic representation of $\mathrm{GL}_n(\mathbb{A})$, then we have an equality of degree $5n$ Rankin-Selberg L -functions $L(s, \mathrm{std}(\pi) \times \sigma) = L(s, \Pi_5 \times \sigma)$ and therefore $L(s, \mathrm{std}(\pi) \times \sigma)$ satisfies the usual properties of an L -function. If $n \leq 2$, and σ has the property that the set of finite primes where it is ramified is either empty or contains at least one prime not dividing N , then $L(s, \mathrm{std}(\pi) \times \sigma)$ is entire.
- iii) The degree 10 L -function $L(s, \mathrm{ad}(\pi))$ satisfies the usual properties of an L -function, is entire, and has no zeroes on the line $\mathrm{Re}(s) = 1$.

Proof. Since F corresponds to the “general” Arthur parameter, Arthur’s work [Art13] (see also Section 1.1 of [Sch18]) shows that π has a strong lifting to a cuspidal automorphic representation Π_4 of GL_4 ; clearly Π_4 has trivial central character since π does. It is known from [Art13, Thm. 1.5.3] that Π_4 is self-dual and symplectic⁶. The fact that the lifting is “strong”, i.e., corresponds to a local lift at *all* places, implicitly uses that the local parameters of Arthur coincide with the local Langlands parameters of Gan–Takeda [GT11]; this consistency of local parameters follows from [CG15]. The required properties of $L(s, \pi \times \sigma)$ now follow from Rankin–Selberg theory of GL_n .

For the second assertion, let \wedge^2 denotes the exterior square, and note that $\wedge^2 \rho_4 = \mathbf{1} + \rho_5$, hence

$$(56) \quad L(s, \Pi_4, \wedge^2) = L(s, \mathrm{std}(\pi))\zeta(s).$$

Recall that $L(s, \Pi_4 \times \Pi_4) = L(s, \Pi_4, \mathrm{Sym}^2)L(s, \Pi_4, \wedge^2)$. Since Π_4 is symplectic, $L(s, \Pi_4, \wedge^2)$ has a simple pole at $s = 1$ and $L(s, \Pi_4, \mathrm{Sym}^2)$ is an entire function by [BG92, Thm. 7.5]. It follows from (56) that $L(s, \mathrm{std}(\pi))$ is holomorphic and non-zero at $s = 1$. Together with [Gri79, Theorem 2], we obtain that $L(s, \mathrm{std}(\pi))$ has no poles on $\mathrm{Re}(s) = 1$. On the other hand, by [Kim03, Thm. A] and [Hen09] $L(s, \Pi_4, \wedge^2)$ is the L -function of an automorphic representation of $\mathrm{GL}_6(\mathbb{A})$ of the form $\mathrm{Ind}(\tau_1 \otimes \dots \otimes \tau_m)$ where τ_1, \dots, τ_m are unitary, cuspidal, automorphic representations of $\mathrm{GL}_{n_i}(\mathbb{A})$, $n_1 + \dots + n_m = 6$. Since $L(s, \Pi_4, \wedge^2)$ has a simple pole at $s = 1$, it follows that exactly one of the τ_i , say τ_m , is the trivial representation of $\mathrm{GL}_1(\mathbb{A})$. Cancelling out one zeta factor, we see that

$$(57) \quad L(s, \mathrm{std}(\pi)) = L(s, \tau_1) \cdots L(s, \tau_{m-1}).$$

So we take $\Pi_5 = \mathrm{Ind}(\tau_1 \otimes \dots \otimes \tau_{m-1})$; the above discussion shows that Π_5 is a (strong) lifting of π from $\mathrm{GSp}_4(\mathbb{A})$ to $\mathrm{GL}_5(\mathbb{A})$ with respect to the map ρ_5 of dual groups $\mathrm{GSp}_4(\mathbb{C}) \rightarrow \mathrm{SO}_5(\mathbb{C}) \subset \mathrm{GL}_5(\mathbb{C})$. Observe that each τ_i is unitary, cuspidal, and unramified outside primes dividing N . By Rankin–Selberg theory, $L(s, \Pi_5 \times \sigma) = \prod_{i=1}^{m-1} L(s, \tau_i \times \sigma)$ satisfies the usual properties of an L -function. To complete the proof, it suffices to show that if σ is an irreducible cuspidal representation of $\mathrm{GL}_1(\mathbb{A})$ or $\mathrm{GL}_2(\mathbb{A})$ such that the set of ramification primes for σ is either empty or contains at least one prime outside N , then $\tau_i \not\simeq \hat{\sigma}$ for each i . First, consider the case that σ is a character, in which case we are reduced to $n_i = 1$. In this case, since τ_i is unramified outside N , the assumption on σ means that the situation $\tau_i \simeq \hat{\sigma}$ will force τ_i to be unramified everywhere, in which case the right hand side of (57) would have a pole on $\mathrm{Re}(s) = 1$. This contradicts the observation from above that $L(s, \mathrm{std}(\pi))$ has no poles on $\mathrm{Re}(s) = 1$. Next consider the case that σ is a cuspidal representation of $\mathrm{GL}_2(\mathbb{A})$. An identical argument to the above reduces us to the case where $\tau_i \simeq \hat{\sigma}$ is unramified at all finite primes. The easy relation $\wedge^2 \rho_5 = \mathrm{Sym}^2 \rho_4 = \rho_{10}$ implies that

$$(58) \quad L(s, \Pi_5, \wedge^2) = L(s, \mathrm{ad}(\pi)) = L(s, \Pi_4, \mathrm{Sym}^2),$$

⁵By this we mean that this L -function has meromorphic continuation to the entire complex plane, satisfies the standard functional equation taking $s \mapsto 1 - s$, has an Euler product, and is bounded in vertical strips (in particular, the L -function is in the extended Selberg class).

⁶Recall that a self-dual representation Π of $\mathrm{GL}_n(\mathbb{A})$ is said to be symplectic if $L(s, \mathrm{Sym}^2 \Pi)$ is holomorphic at $s = 1$.

which we know is an entire function. On the other hand, if some τ_i in (57) has $n_i = 2$ and is unramified at all finite primes, then $L(s, \Pi_5, \wedge^2)$ will contain a factor of $L(s, \omega_{\tau_i})$ and so will have a pole on $\text{Re}(s) = 1$. This contradiction completes the proof that each $L(s, \tau_i \times \sigma)$ and hence $L(s, \Pi_5 \times \sigma)$ is entire.

Finally, the assertion concerning the degree 10 L -function $L(s, \text{ad}(\pi))$ follows from the identity (58) and the fact that $L(s, \Pi_4, \text{Sym}^2)$ represents a holomorphic L -function. Since symmetric square L -functions are accessible via the Langlands-Shahidi method, the non-vanishing on $\text{Re}(s) = 1$ follows (see Sect. 5 of [Sha81] and [Sha97, Thm 1.1]). \square

For our future applications, we will also need that $L(s, \text{ad}(\pi) \times \sigma)$ has the properties of an L -function and is entire for certain special automorphic representations σ of $\text{GL}_1(\mathbb{A})$ or $\text{GL}_2(\mathbb{A})$. The next two lemmas achieve this for σ a quadratic character or σ of the form $\mathcal{A}\mathcal{J}(\Lambda^2)$ where Λ is a character of \mathbb{A}_K^\times where K is a quadratic field and $\mathcal{A}\mathcal{J}$ denotes automorphic induction.

Lemma 5.5. *Let K/\mathbb{Q} be a quadratic field. Let F and π be as in Proposition 5.4 and assume that N is squarefree. Then the base change π_K of π to $\text{GSp}_4(\mathbb{A}_K)$ is cuspidal. Furthermore, the base change $\Pi_{4,K}$ of Π_4 to $\text{GL}_4(\mathbb{A}_K)$ is cuspidal and $\Pi_{4,K}$ is the lifting of π_K from $\text{GSp}_4(\mathbb{A}_K)$ to $\text{GL}_4(\mathbb{A}_K)$.*

Proof. Let π_K and $\Pi_{4,K}$ be as in the statement of the lemma. Since Π_4 is the lifting of π , it follows from the definition of base change that $\Pi_{4,K}$ is the lifting of π_K . Let σ be an arbitrary cuspidal automorphic representation of $\text{GL}_1(\mathbb{A}_K)$ or $\text{GL}_2(\mathbb{A}_K)$. By the definition of lifting, we have

$$L(s, \pi_K \times \sigma) = L(s, \Pi_{4,K} \times \sigma)$$

and so to prove that π_K and $\Pi_{4,K}$ are cuspidal it suffices to show that $L(s, \Pi_{4,K} \times \sigma)$ has no poles. By the adjointness formula [PR99, Prop 3.1] we have $L(s, \Pi_{4,K} \times \sigma) = L(s, \Pi_4 \times \mathcal{A}\mathcal{J}(\sigma))$. Note that $\mathcal{A}\mathcal{J}(\sigma)$ is an automorphic representation of $\text{GL}_2(\mathbb{A})$ if σ is a character of \mathbb{A}_K^\times and $\mathcal{A}\mathcal{J}(\sigma)$ is an automorphic representation of $\text{GL}_4(\mathbb{A})$ if σ is a cuspidal representation of $\text{GL}_2(\mathbb{A}_K)$. By Proposition 5.4, $L(s, \Pi_4 \times \mathcal{A}\mathcal{J}(\sigma))$ is entire when σ is a character. This reduces us to the case that σ is a cuspidal representation of $\text{GL}_2(\mathbb{A}_K)$; in this case $L(s, \Pi_{4,K} \times \sigma) = L(s, \Pi_4 \times \mathcal{A}\mathcal{J}(\sigma))$ has a pole if and only if $\Pi_4 \simeq \mathcal{A}\mathcal{J}(\sigma)$ (recall that Π_4 is self-dual). However, by looking at a prime p which ramifies in K , we see that this is impossible: at any such prime, the local Langlands parameter of $\Pi_{4,p}$ is the local lifting of a representation of $\text{GSp}_4(\mathbb{Q}_p)$ that has a vector fixed by the local Siegel congruence subgroup of level p (since N is squarefree), but an inspection of Table 1 of [JLR12] tells us that the local parameter of $\mathcal{A}\mathcal{J}(\sigma_p)$ can never equal one of those. Hence we have completed the proof that $L(s, \Pi_{4,K} \times \sigma)$ has no poles. \square

Remark 5.6. The above proof crucially relies on the fact that F has squarefree level N . If N is allowed to be divisible by squares of primes, there indeed exists F whose adelization generates a representation π whose base change π_K (for certain K) is non-cuspidal. Such F are constructed in [JLR12] for K real quadratic and [BDPc15] for K imaginary quadratic.

Lemma 5.7. *Let K/\mathbb{Q} be a quadratic field. Let F and π be as in Proposition 5.4 and assume that N is squarefree. Let χ_K be the quadratic Dirichlet character associated to the extension K/\mathbb{Q} . Let Λ be any idele class character of $K^\times \backslash \mathbb{A}_K^\times$. Then the degree 10 L -function $L(s, \text{ad}(\pi) \times \chi_K)$ and the degree 20 L -function $L(s, \text{ad}(\pi) \times \mathcal{A}\mathcal{J}(\Lambda^2))$ both satisfy the usual properties of an L -function, and are both entire.*

Proof. It can be verified (as a formal identity that holds at each place) that

$$L(s, \text{Sym}^2(\pi_{4,K} \times \Lambda)) = L(s, \text{ad}(\pi) \times \mathcal{A}\mathcal{J}(\Lambda^2)).$$

By Lemma 5.5, $\pi_{4,K} \times \Lambda$ is a cuspidal representation of $\mathrm{GL}_4(\mathbb{A}_K)$. Furthermore, if $\pi_{4,K} \times \Lambda$ is self-dual, then it must be symplectic since $\Pi_{4,K} \times \Lambda$ is the lift of $\pi_K \times \Lambda$ from $\mathrm{GSp}_4(\mathbb{A}_K)$ to $\mathrm{GL}_4(\mathbb{A}_K)$. So by [BG92, Thm. 7.5], $L(s, \mathrm{ad}(\pi) \times \mathcal{AJ}(\Lambda^2))$ has the properties of an L -function and is entire.

To show the same fact for $L(s, \mathrm{ad}(\pi) \times \chi_K) = L(s, \mathrm{Sym}^2(\Pi_4) \times \chi_K)$ we appeal to [Tak15, Thm. p. 104], which shows that the only possible poles of $L(s, \mathrm{Sym}^2(\Pi_4) \times \chi_K)$ are at $s = 0, 1$ (these two possible poles are related by the functional equation). However, by what we have already proved, $L(s, \mathrm{ad}(\pi) \times \mathcal{AJ}(1)) = L(s, \mathrm{ad}(\pi))L(s, \mathrm{ad}(\pi) \times \chi_K)$ is entire. So a pole at $s = 1$ for $L(s, \mathrm{ad}(\pi) \times \chi_K)$ will imply that $L(1, \mathrm{ad}(\pi)) = 0$. This contradicts the last part of Proposition 5.4. \square

Remark 5.8. Let $F \in S_k(\Gamma_0^{(2)}(N))^{\mathrm{G}}$ give rise to an irreducible representation π and assume that N is squarefree. Let d be a fundamental discriminant that is divisible by at least one prime not dividing N , put $K = \mathbb{Q}(\sqrt{d})$, and let χ_d be the quadratic Dirichlet character associated to K/\mathbb{Q} and let Λ be a character of the ideal class group Cl_K . Then combining Proposition 5.4 and Lemma 5.7, we see that the L -functions $L(s, \pi \times \mathcal{AJ}(\Lambda))$, $L(s, \mathrm{ad}(\pi) \times \mathcal{AJ}(\Lambda^2))$, $L(s, \mathrm{ad}(\pi) \times \chi_d)$, $L(s, \mathrm{std}(\pi) \times \mathcal{AJ}(\Lambda^2))$, $L(s, \mathrm{std}(\pi) \times \chi_d)$ are all holomorphic everywhere in the complex plane.

5.5. A consequence of the refined Gan–Gross–Prasad identity. Let $K = \mathbb{Q}(\sqrt{d})$ where $d < 0$ is a fundamental discriminant. Recall from the introduction that for any character Λ of the finite group Cl_K , we define $B(F, \Lambda) = \sum_{S \in \mathrm{Cl}_K} a(F, S)\Lambda(S)$. The refined Gan–Gross–Prasad (GGP) conjecture in the context of Bessel periods of $\mathrm{PGSp}_4 \simeq \mathrm{SO}_5$ (and more generally, for Bessel periods of orthogonal groups) was formulated in [Liu16, (1.1)], and made more explicit in the context of Siegel cusp forms in [DPSS20]. This conjecture implies an identity expressing the square of $|B(F, \Lambda)|$ as a ratio of L -values, up to some local integrals. For the purpose of this paper, we only need a relatively weak consequence of this identity, which we formulate explicitly as *Hypothesis G* below. In this subsection we do not assume that N is squarefree.

Suppose that $F \in S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$ gives rise to an irreducible representation π . Then F is said to satisfy **Hypothesis G** if there exists a constant C_F such that for each imaginary quadratic field $K = \mathbb{Q}(\sqrt{d})$ (with $d < 0$ a fundamental discriminant) and each character Λ of Cl_K we have

$$(59) \quad |B(F, \Lambda)|^2 \leq C_F |d|^{k-1} L\left(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)\right).$$

Proposition 5.9. *Let π be an irreducible representation that arises from $S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$. Suppose that for each factorizable $F \in S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$ that gives rise to π , and each ideal class character Λ of an imaginary quadratic field $K = \mathbb{Q}(\sqrt{d})$ (with d a fundamental discriminant), the refined Gan–Gross–Prasad identity (in the form written down in Conjecture 1.3 of [DPSS20]) holds for (ϕ, Λ) , where ϕ is the adelization of F . Then any $F \in S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$ that gives rise to π satisfies Hypothesis G.*

Proof. Note that the subspace of $S_k(\Gamma_0^{(2)}(N))^{\mathrm{T}}$ generated by forms that give rise to a fixed irreducible representation π , has a basis consisting of factorizable forms. So, for the purpose of verifying Hypothesis G, it suffices to prove (59) for factorizable F whose adelization $\phi = \otimes \phi_v$ generates π . Assuming the truth of Conjecture 1.2 of [DPSS20] for (ϕ, Λ) , and combining it with the explicit calculations performed in [DPSS20, §2.2, §3.3–3.5], we see that

$$|B(F, \Lambda)|^2 = A_F |d|^{k-1} L\left(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)\right) \prod_{p|N_F} J_p(\phi_p, \Lambda_p)$$

where A_F depends on F , $N_F|N$ is the smallest integer such that $F \in S_k(\Gamma_0^{(2)}(N_F))^{\mathrm{T}}$, and the normalized local factors $J_p(\phi_p, \Lambda_p)$ (which depend on p , ϕ_p , Λ_p and d) are defined in [DPSS20, (30)]. To complete the proof, it suffices to show that $J_p(\phi_p, \Lambda_p) \ll_{p, \phi_p} 1$ (i.e., is bounded by some constant that depends on p , ϕ_p but not on d or Λ_p). It suffices to show this for the unnormalized

local factors $J_{0,p}(\phi_p, \Lambda_p)$ defined in [DPSS20, (29)] since the normalized local L -factors $J_p(\phi_p, \Lambda_p)$ only differ from these by certain absolutely bounded L -factors appearing in [DPSS20, (30)].

To show the above, we move to a purely local setup. Let p be a prime dividing N_F . Let $F = \mathbb{Q}_p$. We fix a set M of coset representatives of $F^\times / (F^\times)^2$ such that all elements of M are taken from \mathbb{Z}_p , and each $r \in M$ generates the discriminant ideal of $F(\sqrt{r})/F$. We let r_p equal the unique representative in M that corresponds to d . The assumptions imply that

$$r_p = du_p^2, \quad \text{for some } u \in (\mathbb{Z}_p^\times)^2.$$

Let K equal $F \times F$ (the ‘‘split case’’) if $r_p \in F^2$ and $K = F(\sqrt{r_p}) = F(\sqrt{d})$ (the ‘‘field case’’) if $r_p \notin F^2$. Fix the matrix $S = S_d$ as in [DPSS20, (75)], so that S_d has discriminant d . Let $T(F) = T_S(F) \simeq K^\times$ be the associated subgroup of $\mathrm{GSp}_4(F)$, let $N(F) \subset \mathrm{GSp}_4(F)$ denote the unipotent for the Siegel parabolic and θ_S the character on $N(F)$ given by $\theta_S\left(\begin{pmatrix} I_2 & X \\ 0 & I_2 \end{pmatrix}\right) = \psi(\mathrm{tr}(SX))$ where ψ is a fixed unramified additive character. Then we need to show that the integral

$$J_{0,p}(\phi_p, \Lambda_p) = \int_{F^\times \backslash T(F)} \int_{N(F)}^{\mathrm{St}} \langle \pi_p(t_p n_p) \phi_p, \phi_p \rangle \Lambda_p^{-1}(t_p) \theta_S^{-1}(n_p) dn_p dt_p$$

is bounded by some quantity that does not depend on d or Λ_p . Note above that the superscript St denotes stable integral as in [Liu16]; this means that the integral can be replaced by any sufficiently large compact subgroup (as we will do below). Put $S' = \begin{pmatrix} -\frac{r_p}{4} & 0 \\ 0 & 1 \end{pmatrix}$, $A' = \begin{pmatrix} u_p & 0 \\ 0 & 1 \end{pmatrix}$ if $d \equiv 0 \pmod{4}$. In the case that $d \equiv 1 \pmod{4}$ we put $S' = \begin{pmatrix} \frac{1-r_p}{4} & \frac{1}{2} \\ \frac{1}{2} & 1 \end{pmatrix}$, $A' = \begin{pmatrix} u_p & 0 \\ \frac{1-u_p}{2} & 1 \end{pmatrix}$. In either case, $A' \in \mathrm{GL}_2(\mathbb{Z}_p)$ and $S' = {}^tASA$. To show that J_p is bounded independently of d , we use a simple change of variables ($n_p \mapsto An_p {}^tA$, $t_p \mapsto At_p A^{-1}$) to see that the integral $J_{0,p}(\phi_p, \Lambda_p)$ remains unchanged when the matrix S is replaced by S' . This shows that $J_{0,p}(\phi_p, \Lambda_p)$ does not depend on the actual value of d but only on the class of d in $F^\times / (F^\times)^2$ together with d modulo 4, of which there are only finitely many possibilities. To show that the resulting integral is absolutely bounded independent of Λ , we replace the integral $\int_{N(F)}^{\mathrm{St}}$ by $\int_{p^{-m_p}N(\mathbb{Z}_p)}$ where m_p depends only on the level N (as follows from the argument of [DPSS20, Prop. 2.14]). The resulting integral is absolutely convergent [Liu16, Thm. 2.1 (i)] and hence bounded independently of Λ . \square

Remark 5.10. Furusawa and Morimoto [FMng] have proved the refined GGP identity in the form required in Prop. 5.9 for $\Lambda = 1_K$, and they have announced a proof of this identity for general Λ .

Remark 5.11. Under certain assumptions (namely N odd and squarefree, F a newform, and $\left(\frac{d}{p}\right) = -1$ for all primes p dividing N) the relevant local integrals were explicitly computed in [DPSS20], and so under these assumptions Proposition 5.9 follows from Theorem 1.13 of [DPSS20].

Corollary 5.12. *Suppose that $F \in S_k(\Gamma_0^{(2)}(N))^Y$ gives rise to an irreducible representation. Then F satisfies Hypothesis G.*

Proof. This follows from Proposition 5.9 since the refined Gan–Gross–Prasad conjecture is known for Yoshida lifts by [Liu16, Thm 4.3]. \square

The proof of Corollary 1.1. Let π be a cuspidal automorphic representation of $\mathrm{GSp}_4(\mathbb{A})$ that arises from a form $F \in S_k(\Gamma_0^{(2)}(N))^T$ with $k > 2$ even and N odd and squarefree. Assume that the refined Gan–Gross–Prasad identity holds. Then for any fundamental matrix $S \in \Lambda_2$ of discriminant d , we

put $K = \mathbb{Q}(\sqrt{d})$ and use Cauchy-Schwarz and Proposition 5.9 to conclude

$$\begin{aligned} |a(F, S)|^2 &= \frac{1}{|\text{Cl}_K|^2} \left| \sum_{\Lambda \in \widehat{\text{Cl}_K}} B(F, \Lambda) \Lambda^{-1}(S) \right|^2 \leq \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}_K}} |B(F, \Lambda)|^2 \\ &\ll_{\pi} |d|^{k-1} \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}_K}} L(\tfrac{1}{2}, \pi \times \mathcal{A}\mathcal{J}(\Lambda)). \end{aligned}$$

The proof of the Corollary now follows from Theorem B. \square

The proof of Corollary 1.2. For f, g as in Corollary 1.2, and $N = \text{lcm}(N_1, N_2)$ there exists $F \in S_k(\Gamma_0^{(2)}(N))^Y$ which gives rise to an irreducible representation π such that (see [SS13, Prop. 3.1])

$$L(s, \pi \times \mathcal{A}\mathcal{J}(\Lambda)) = L(s, f \times \mathcal{A}\mathcal{J}(\Lambda)) L(s, g \times \mathcal{A}\mathcal{J}(\Lambda)).$$

Now Corollary 1.2 follows from Corollary 1.1 and the triangle inequality. \square

Proposition 5.13. *Suppose that $F \in S_k(\Gamma_0^{(2)}(N))^{\text{CAP}}$ gives rise to an irreducible representation π such that $L^N(s, \pi) = L^N(s, \pi_0) \zeta^N(s + \frac{1}{2}) \zeta^N(s - \frac{1}{2})$ where π_0 is a representation of $\text{GL}_2(\mathbb{A})$. Then the Fourier coefficients of F at fundamental matrices depend only on the associated discriminant, i.e., if S_1, S_2 are two fundamental matrices with the same discriminant d , then $a(F, S_1) = a(F, S_2)$. Furthermore, there exists a constant C_F such that for each fundamental discriminant d and any matrix S of discriminant d , we have*

$$|a(F, S)| \leq C_F |d|^{\frac{k}{2} - \frac{3}{4}} L(\tfrac{1}{2}, \pi_0 \times \chi_d)^{1/2}.$$

Proof. An analogue of the Gan–Gross–Prasad conjecture for representations of Saito-Kurokawa type was formulated and proved by Qiu in [Qiu14]. In particular, we have $B(F, \Lambda) = 0$ unless Λ is the trivial character, which proves the assertion that the Fourier coefficients of F at fundamental matrices depend only on the discriminant. For Λ trivial, the desired inequality follows in a similar fashion as in the proof of Proposition 5.9. \square

5.6. The proof of Theorem C. In this subsection we restate and prove Theorem C, assuming the main result of Section 6.

Theorem 5.14. *Let $k > 2$ be even and $N \geq 1$ be squarefree.*

- i) *Assume that the GRH holds for each of the L -functions $L(s, \pi \times \mathcal{A}\mathcal{J}(\Lambda))$, $L(s, \text{ad}(\pi) \times \mathcal{A}\mathcal{J}(\Lambda^2))$, $L(s, \text{ad}(\pi) \times \chi_d)$, $L(s, \text{std}(\pi) \times \mathcal{A}\mathcal{J}(\Lambda^2))$, $L(s, \text{std}(\pi) \times \chi_d)$, $L(s, \sigma \times \chi_d)$ and $L(s, \chi_d)$, where π is any automorphic representation of $\text{GSp}_4(\mathbb{A})$ that arises from $S_k(\Gamma_0^{(2)}(N))^G$, σ is any cuspidal automorphic representation of $\text{GL}_2(\mathbb{A})$, $K = \mathbb{Q}(\sqrt{d})$ is an imaginary quadratic field with associated Dirichlet character χ_d , and Λ is an ideal class character of K .*
- ii) *Assume that each $F' \in S_k(\Gamma_0^{(2)}(N))^G$ that gives rise to an irreducible representation satisfies Hypothesis G (by Proposition 5.9 this is implied by the refined GGP conjecture).*

Then, given any $F \in S_k(\Gamma_0^{(2)}(N))$ we have for fundamental matrices S ,

$$(60) \quad |a(F, S)| \ll_{F, \varepsilon} \frac{|\text{disc}(S)|^{\frac{k}{2} - \frac{1}{2}}}{(\log |\text{disc}(S)|)^{\frac{1}{8} - \varepsilon}}.$$

Proof. Since $S_k(\Gamma_0^{(2)}(N))$ has a basis consisting of forms that give rise to irreducible representations, it suffices to prove (60) for such forms F . Furthermore, we may assume that $d = \text{disc}(S)$ is divisible by at least one prime not dividing N , since there are at most finitely many fundamental S without this property. Let F give rise to π . We consider three cases, corresponding to (55).

Case 1: π is of Saito-Kurokawa type. In this case, using Proposition 5.13, the desired inequality follows from any subconvexity bound for $L(\frac{1}{2}, \pi_0 \times \chi_d)$ which is known. (In particular, for this case, we do not need to appeal to GRH for $L(s, \pi_0 \times \chi_d)$).

Case 2: π is of Yoshida type, i.e., $F \in S_k(\Gamma_0^{(2)}(N))^Y$. In this case, there are inequivalent representations σ_1 and σ_2 of $\mathrm{GL}_2(\mathbb{A})$ such that $L(\frac{1}{2}, \pi \times \mathcal{A}\mathcal{J}(\Lambda)) = L(\frac{1}{2}, \sigma_1 \times \mathcal{A}\mathcal{J}(\Lambda)) L(\frac{1}{2}, \sigma_2 \times \mathcal{A}\mathcal{J}(\Lambda))$. Using the identity $a(F, S) = \frac{1}{|\mathrm{Cl}_K|} \sum_{\Lambda \in \widehat{\mathrm{Cl}}_K} B(F, \Lambda) \Lambda^{-1}(S)$ and Corollary 5.12, we conclude that

$$a(F, S) \ll_F |d|^{\frac{k}{2} - \frac{1}{2}} \frac{1}{|\mathrm{Cl}_K|} \sum_{\Lambda \in \widehat{\mathrm{Cl}}_K} \sqrt{L(\frac{1}{2}, \sigma_1 \times \mathcal{A}\mathcal{J}(\Lambda)) L(\frac{1}{2}, \sigma_2 \times \mathcal{A}\mathcal{J}(\Lambda))}.$$

Now the desired conclusion follows from Theorem 3 of [BB20].

Case 2: π is of general type, i.e., $F \in S_k(\Gamma_0^{(2)}(N))^G$.

In this case, using $a(F, S) = \frac{1}{|\mathrm{Cl}_K|} \sum_{\Lambda \in \widehat{\mathrm{Cl}}_K} B(F, \Lambda) \Lambda^{-1}(S)$ and Hypothesis G, we get

$$a(F, S) \ll_F |d|^{\frac{k}{2} - \frac{1}{2}} \frac{1}{|\mathrm{Cl}_K|} \sum_{\Lambda \in \widehat{\mathrm{Cl}}_K} \sqrt{L(\frac{1}{2}, \pi \times \mathcal{A}\mathcal{J}(\Lambda))}.$$

Now the desired conclusion follows from Theorem 6.1 which will be proved in the next Section. \square

6. FRACTIONAL MOMENTS OF CENTRAL L -VALUES

6.1. Statement of result. Throughout this section, we let π denote an irreducible cuspidal automorphic representation of $\mathrm{GSp}_4(\mathbb{A})$ that arises from $S_k(\Gamma_0(N))^G$ (see Section 5.4). Assume that $N \geq 1$ is squarefree and $k \geq 2$. Let $K = \mathbb{Q}(\sqrt{d})$ be a quadratic field such that $d < 0$ is a fundamental discriminant divisible by at least one prime not dividing N and let Cl_K denote the ideal class group of K . Also, given $\Lambda \in \widehat{\mathrm{Cl}}_K$ we let $\mathcal{A}\mathcal{J}(\Lambda)$ denote the automorphic representation of $\mathrm{GL}_2(\mathbb{A})$ given by automorphic induction; it is generated by the theta series $\Theta_\Lambda(z) = \sum_{\mathfrak{a} \neq \mathfrak{a} \in \mathfrak{o}_K} \Lambda(\mathfrak{a}) e(N(\mathfrak{a})z)$. Our assumptions imply that the L -functions $L(s, \pi \times \mathcal{A}\mathcal{J}(\Lambda))$, $L(s, \mathrm{ad}(\pi) \times \mathcal{A}\mathcal{J}(\Lambda^2))$, $L(s, \mathrm{ad}(\pi) \times \chi_d)$, $L(s, \mathrm{std}(\pi) \times \mathcal{A}\mathcal{J}(\Lambda^2))$, $L(s, \mathrm{std}(\pi) \times \chi_d)$ are all entire (see Remark 5.8). Using Soundararajan's method [Sou09] for bounding moments of L -functions we will prove the following result.

Theorem 6.1. *Assume GRH for each of the L -functions $L(s, \pi \times \mathcal{A}\mathcal{J}(\Lambda))$, $L(s, \mathrm{ad}(\pi) \times \mathcal{A}\mathcal{J}(\Lambda^2))$, $L(s, \mathrm{ad}(\pi) \times \chi_d)$, $L(s, \mathrm{std}(\pi) \times \mathcal{A}\mathcal{J}(\Lambda^2))$, $L(s, \mathrm{std}(\pi) \times \chi_d)$, and $L(s, \chi_d)$. Then*

$$\frac{1}{|\mathrm{Cl}_K|} \sum_{\Lambda \in \widehat{\mathrm{Cl}}_K} \sqrt{L(\frac{1}{2}, \pi \times \mathcal{A}\mathcal{J}(\Lambda))} \ll_{\pi, \varepsilon} \frac{1}{(\log |d|)^{\frac{1}{8} - \varepsilon}}.$$

Related moment estimates for families of L -functions have been established in [MTB14, LR20, HL20, BB20]. Since we assume GRH, we immediately get that $L(\frac{1}{2}, \pi \times \mathcal{A}\mathcal{J}(\Lambda)) \geq 0$, however this is known unconditionally due to [Lap03, Theorem 1.1], so the square root of the central value is unambiguous, independent of the truth of any unproven hypothesis.

6.2. Local computation. For $\mathrm{Re}(s) > 1$ the L -function $L(s, \pi)$ is given by

$$L(s, \pi) = \prod_p L(s, \pi_p), \quad L(s, \pi_p) = \left(1 - \frac{\alpha_p}{p^s}\right)^{-1} \left(1 - \frac{\alpha_p^{-1}}{p^s}\right)^{-1} \left(1 - \frac{\beta_p}{p^s}\right)^{-1} \left(1 - \frac{\beta_p^{-1}}{p^s}\right)^{-1}$$

for $p \nmid N$, where $\mathcal{S}_p(\pi) = \{\alpha_p, \alpha_p^{-1}, \beta_p, \beta_p^{-1}\}$ are the Satake parameters of π and it is known that $|\alpha_p| = |\beta_p| = 1$ by [Wei09]. Also, given $\Lambda \in \widehat{\mathrm{Cl}}_K$ we have for $\mathrm{Re}(s) > 1$

$$L(s, \mathcal{A}\mathcal{J}(\Lambda)) = \prod_p L(s, \mathcal{A}\mathcal{J}(\Lambda_p)), \quad L(s, \mathcal{A}\mathcal{J}(\Lambda_p)) = \left(1 - \frac{\alpha_{\Lambda_p}}{p^s}\right)^{-1} \left(1 - \frac{\beta_{\Lambda_p}}{p^s}\right)^{-1}$$

for $p \nmid N$, where the Satake parameters $\mathcal{S}_p(\mathcal{A}\mathcal{J}(\Lambda)) = \{\alpha_{\Lambda_p}, \beta_{\Lambda_p}\}$ satisfy:

- if $\left(\frac{d}{p}\right) = 1$ then $p\mathfrak{o}_k = \mathfrak{p}\bar{\mathfrak{p}}$ and $\alpha_{\Lambda_p} = \Lambda(\mathfrak{p})$, $\beta_{\Lambda_p} = \Lambda(\bar{\mathfrak{p}}) = \overline{\alpha_{\Lambda_p}}$;
- if $\left(\frac{d}{p}\right) = -1$ then $\alpha_{\Lambda_p} = 1$ and $\beta_{\Lambda_p} = -1$;

- if $p|d$ then $p\mathcal{O}_k = \mathfrak{p}^2$ and $\alpha_{\Lambda_p} = \Lambda(\mathfrak{p})$, $\beta_{\Lambda_p} = 0$.

In the notation above, we have that the Satake parameters of $L(s, \text{std}(\pi))$ and $L(s, \text{ad}(\pi))$ are respectively given by:

- $\mathcal{S}_p(\text{std}(\pi)) = \{1, \alpha_p \beta_p, \alpha_p \beta_p^{-1}, \alpha_p^{-1} \beta_p, \alpha_p^{-1} \beta_p^{-1}\}$;
- $\mathcal{S}_p(\text{ad}(\pi)) = \{\alpha_p^2, \alpha_p^{-2}, \beta_p^2, \beta_p^{-2}, \alpha_p \beta_p, \alpha_p^{-1} \beta_p, \alpha_p \beta_p^{-1}, \alpha_p^{-1} \beta_p^{-1}, 1, 1\}$.

Define for $\star \in \{\pi, \mathcal{AJ}(\Lambda), \text{std}(\pi), \text{ad}(\pi)\}$ and $p \nmid N$

$$a_\star(p^n) = \sum_{\alpha \in \mathcal{S}_p(\star)} \alpha^n.$$

Also, for $f, g \in \{\pi, \mathcal{AJ}(\Lambda), \text{std}(\pi), \text{ad}(\pi)\}$ let $a_{f \times g}(p^n) = a_f(p^n) a_g(p^n)$ and $a_{f \times \chi_d}(p^n) = a_f(p^n) \chi_d(p^n)$.

We now make the following observations. First, using that $|\alpha_p| = |\beta_p| = 1$ it immediately follows that for any $n \geq 1$ and $p \nmid N$

$$(61) \quad |a_{\pi \times \mathcal{AJ}(\Lambda)}(p^n)| \leq 8.$$

Additionally, observe for $p \nmid N$ that

$$a_{\text{ad}(\pi)}(p) = \alpha_p^2 + \alpha_p^{-2} + \beta_p^2 + \beta_p^{-2} + a_{\text{std}(\pi)}(p) + 1.$$

Hence, for $p \nmid N$

$$(62) \quad a_\pi(p^2) = a_{\text{ad}(\pi)}(p) - a_{\text{std}(\pi)}(p) - 1.$$

Also, for $p \nmid N$

$$(63) \quad \begin{aligned} a_\pi(p)^2 &= \alpha_p^2 + \alpha_p^{-2} + \beta_p^2 + \beta_p^{-2} + 2(\alpha_p + \alpha_p^{-1})(\beta_p + \beta_p^{-1}) + 4 \\ &= a_{\text{ad}(\pi)}(p) + a_{\text{std}(\pi)}(p) + 1. \end{aligned}$$

Recall that for $\left(\frac{d}{p}\right) \neq -1$, $\alpha_{\Lambda_p}^2 = \Lambda^2(\mathfrak{p}) = \alpha_{\Lambda_p^2}$. Thus, we get that for $p \nmid N$

$$a_{\mathcal{AJ}(\Lambda)}(p^2) = a_{\mathcal{AJ}(\Lambda^2)}(p) + \left(\frac{d}{p}\right)^2 - \left(\frac{d}{p}\right) = \begin{cases} \alpha_{\Lambda_p^2} + \beta_{\Lambda_p^2} & \text{if } \left(\frac{d}{p}\right) \neq -1, \\ 2 & \text{if } \left(\frac{d}{p}\right) = -1. \end{cases}$$

Therefore, combining the above equation with (62) we conclude that

$$(64) \quad a_{\pi \times \mathcal{AJ}(\Lambda)}(p^2) = (a_{\text{ad}(\pi)}(p) - a_{\text{std}(\pi)}(p) - 1) \left(a_{\mathcal{AJ}(\Lambda^2)}(p) + \left(\frac{d}{p}\right)^2 - \left(\frac{d}{p}\right) \right).$$

6.3. Preliminary lemmas. Soundararajan's method for moments of L -functions starts with a remarkable bound for the central L -value given in terms of a Dirichlet polynomial supported on prime powers. This inequality has been generalized by Chandee [Cha09].

Lemma 6.2. *Assume GRH for $L(s, \pi \times \mathcal{AJ}(\Lambda))$. There exists $C_0 > 1$, which depends at most on N, k such that for $x \geq 2$*

$$\log L\left(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)\right) \leq \sum_{\substack{p^n \leq x \\ p \nmid N}} \frac{a_{\pi \times \mathcal{AJ}(\Lambda)}(p^n)}{np^{\frac{n}{2}(1+1/\log x)}} + \frac{C_0 \log |d|}{\log x}.$$

Remark 6.3. Taking $x = \log |d|$ and using (61) it follows that

$$L\left(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)\right) \ll \exp\left(2C_0 \frac{\log |d|}{\log \log |d|}\right).$$

Proof. This follows immediately from [Cha09, Theorem 2.1]. □

To analyze the above sum over prime powers, we will separately consider the primes, squares of primes, and higher prime powers. The contribution of the squares of primes is estimated in the following result.

Lemma 6.4. *Assume GRH. Then for $x \geq 2$ each of the following hold:*

$$\begin{aligned} \text{i)} \quad & \sum_{\substack{p \leq \sqrt{x} \\ p \nmid N}} \frac{a_{\pi \times \mathcal{AJ}(\Lambda)}(p^2) \log x/p}{p^{1+2/\log x} \log x} = -\log \log x(1 + o(1)) + O_\pi(\log \log \log |d|); \\ \text{ii)} \quad & \sum_{\substack{p \leq x \\ p \nmid N, \left(\frac{d}{p}\right)=1}} \frac{a_\pi(p)^2}{p} = \frac{1}{2} \log \log x(1 + o(1)) + O_\pi(\log \log \log |d|). \end{aligned}$$

Remark 6.5. We assume GRH holds for $L(s, \chi_d)$, $L(s, \pi \times \mathcal{AJ}(\Lambda))$, $L(s, \text{ad}(\pi) \times \mathcal{AJ}(\Lambda^2))$, $L(s, \text{ad}(\pi) \times \chi_d)$, $L(s, \text{std}(\pi) \times \mathcal{AJ}(\Lambda^2))$, and $L(s, \text{std}(\pi) \times \chi_d)$.

Proof. Using that $|\alpha_p| = |\beta_p| = 1$, we get for $x \geq (\log |d|)^3$

$$\sum_{\substack{p \leq x \\ p \nmid N}} \frac{a_{\text{std}(\pi) \times \chi_d}(p)}{p} = \sum_{(\log |d|)^3 \leq p \leq x} \frac{a_{\text{std}(\pi) \times \chi_d}(p)}{p} + O(\log \log \log |d|).$$

By Proposition 5.4, $L(s, \text{std}(\pi) \times \chi_d)$ belongs to the extended Selberg class, so that we may use [BB20, Lemma 5]. Applying this lemma twice it follows that the sum on the r.h.s. is $O_\pi(1)$ and so

$$\sum_{\substack{p \leq x \\ p \nmid N}} \frac{a_{\text{std}(\pi)}(p) \left(\frac{d}{p}\right)}{p} \ll_\pi \log \log \log |d|.$$

Repeating the argument above and recalling Remark 5.8 it follows that for $\star \in \{\text{ad}(\pi) \times \chi_d, \text{ad}(\pi) \times \mathcal{AJ}(\Lambda^2), \text{std}(\pi) \times \mathcal{AJ}(\Lambda^2), \mathcal{AJ}(\Lambda^2)\}$ that $\sum_{\substack{p \leq x \\ p \nmid N}} \frac{a_\star(p)}{p} \ll \log \log \log |d|$. Also, $\sum_{p|d} \frac{1}{p} \ll \log \log \log |d|$ and under GRH we have $\sum_{p \leq x} \frac{\chi_d(p)}{p} \ll \log \log \log |d|$. Finally, using that $L(s, \text{std}(\pi))$ and $L(s, \text{ad}(\pi))$ do not vanish on the line $\text{Re}(s) = 1$, the latter of which follows from Proposition 5.4, we have that (e.g. see [KP03, Theorem 1])

$$\sum_{\substack{p \leq x \\ p \nmid N}} \frac{a_{\text{adj}(\pi)}(p)}{p} = o(\log \log x), \quad \sum_{\substack{p \leq x \\ p \nmid N}} \frac{a_{\text{std}(\pi)}(p)}{p} = o(\log \log x).$$

Therefore, applying (64) and using the estimates above along with partial summation to handle the smooth weight $p^{-2/\log x} \frac{\log x/p}{\log x}$ completes the proof of *i*).

To prove *ii*) we rewrite the condition $\left(\frac{d}{p}\right) = 1$ as $\frac{1}{2} \left(\left(\frac{d}{p}\right) + 1\right)$ for $p \nmid d$, use (63) and argue as above. We trivially bound the contribution of $p|d$ by $\leq 16 \sum_{p|d} \frac{1}{p} \ll \log \log \log |d|$. \square

6.4. Large deviations of Dirichlet polynomials. To bound the frequency which large values of $\log L\left(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)\right)$ occur we will estimate large deviations of the sum over primes in Lemma 6.2 by bounding its moments. This is done in the following fairly standard lemma (e.g. [Sou09, Lemma 3]) whose proof we include for completeness.

Lemma 6.6. *Let $\{b_p\}_p \subset \mathbb{R}$ and $\ell \in \mathbb{N}$. Suppose $x^\ell < \sqrt{|d|}/2$. Then each of the following hold:*

$$\text{i)} \quad \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \left(\sum_{\substack{p \leq x \\ p \nmid d, p \nmid N}} \frac{b_p a_{\mathcal{AJ}(\Lambda)}(p)}{\sqrt{p}} \right)^{2\ell} \leq \frac{(2\ell)!}{2^\ell \ell!} \left(2 \sum_{\substack{p \leq x \\ \left(\frac{d}{p}\right)=1, p \nmid N}} \frac{b_p^2}{p} \right)^\ell;$$

$$\text{ii)} \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \left(\sum_{\substack{p \leq x \\ p|d, p \nmid N}} \frac{b_p a_{AJ(\Lambda)}(p)}{\sqrt{p}} \right)^{2\ell} \leq \frac{(2\ell)!}{2^\ell \ell!} \left(\sum_{\substack{p \leq x \\ p|d, p \nmid N}} \frac{b_p^2}{p} \right)^\ell.$$

Proof. Let $b_n = \prod_{p^j || n} b_p^j$. We have that
(65)

$$\frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \left(\sum_{\substack{p \leq x \\ p|d, p \nmid N}} \frac{b_p a_{AJ(\Lambda)}(p)}{\sqrt{p}} \right)^{2\ell} = \sum_{\substack{n \geq 1 \\ (n, N) = 1}} \frac{b_n}{\sqrt{n}} \sum_{\substack{\mathfrak{p}_1, \dots, \mathfrak{p}_{2\ell} \subset \mathcal{O}_K \\ N(\mathfrak{p}_1 \cdots \mathfrak{p}_{2\ell}) = n \\ N(\mathfrak{p}_j) \leq x \\ \mathfrak{p}_j \text{ split}}} \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \prod_{j=1}^{2\ell} (\Lambda(\mathfrak{p}_j) + \Lambda(\mathfrak{p}_j)^{-1}).$$

For $n \in \mathbb{N}$ in the sum above write $n = q_1^{e_1} \cdots q_r^{e_r}$ where q_1, \dots, q_r are distinct primes with $q_j \mathcal{O}_K = \mathfrak{q}_j \bar{\mathfrak{q}}_j$ for each $j = 1, \dots, r$. The inner sum on the r.h.s. above equals

$$\sum_{0 \leq f_1 \leq e_1} \cdots \sum_{0 \leq f_r \leq e_r} \binom{e_1}{f_1} \cdots \binom{e_r}{f_r} \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \Lambda \left(q_1^{f_1} \bar{q}_1^{e_1 - f_1} \cdots q_r^{f_r} \bar{q}_r^{e_r - f_r} \right).$$

Write $\mathfrak{a} = q_1^{f_1} \bar{q}_1^{e_1 - f_1} \cdots q_r^{f_r} \bar{q}_r^{e_r - f_r}$. Since $N(\mathfrak{a}) \leq x^{2\ell} < |d|/4$, the inner sum above is zero unless $\mathfrak{a} = (\alpha)$ and $\alpha \in \mathbb{Z}$. Hence, the only terms that do not vanish are those with e_1, \dots, e_r even and $f_j = e_j/2$ for $j = 1, \dots, r$. Define the multiplicative functions $\nu(n)$ by $\nu(p^a) = 1/a!$ and $g(n)$ by $g(p^a) = \binom{a}{a/2}$ if $2|a$ and $g(p^a) = 0$ otherwise. The r.h.s. of (65) equals

$$(2\ell)! \sum_{\substack{p|n \Rightarrow p \leq x, p \nmid N \ \& \ \left(\frac{d}{p}\right) = 1 \\ \Omega(n) = 2\ell}} \frac{b_n \nu(n) g(n)}{\sqrt{n}} \leq \frac{(2\ell)!}{2^\ell \ell!} \left(2 \sum_{\substack{p \leq x \\ \left(\frac{d}{p}\right) = 1, p \nmid N}} \frac{b_p^2}{p} \right)^\ell,$$

where for the last inequality we used that the sum on the l.h.s. above is supported on squares and $\nu(m^2)g(m^2) \leq \nu(m)$. This completes the proof of *i*).

Similarly, we have that

$$\frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \left(\sum_{\substack{p \leq x \\ p|d, p \nmid N}} \frac{b_p a_{AJ(\Lambda)}(p)}{\sqrt{p}} \right)^{2\ell} = \sum_{n \geq 1} \frac{b_n}{\sqrt{n}} \sum_{\substack{\mathfrak{p}_1, \dots, \mathfrak{p}_{2\ell} \subset \mathcal{O}_K \\ N(\mathfrak{p}_1 \cdots \mathfrak{p}_{2\ell}) = n \\ N(\mathfrak{p}_j) \leq x \\ \mathfrak{p}_j \text{ ramified}}} \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \Lambda(\mathfrak{p}_1 \cdots \mathfrak{p}_{2\ell}).$$

Write $\mathfrak{a} = \mathfrak{p}_1 \cdots \mathfrak{p}_{2\ell}$. The inner sum is zero unless $\mathfrak{a} = (\alpha)$ with $\alpha \in \mathbb{Z}$, since $N(\mathfrak{a}) < |d|/4$. Consequently, n is a square. The r.h.s. above equals

$$(2\ell)! \sum_{\substack{p|n \Rightarrow p \leq x, p \nmid N \ \& \ p|d \\ \Omega(n) = \ell}} \frac{b_n^2}{n} \nu(n^2) \leq \frac{(2\ell)!}{2^\ell \ell!} \left(\sum_{\substack{p \leq x \\ p|d, p \nmid N}} \frac{b_p^2}{p} \right)^\ell,$$

where we used that $\nu(n^2) \leq \frac{\nu(n)}{2^{\Omega(n)}}$ in the last step. This completes the proof of *ii*). \square

For $x \geq 2$, let $P(\Lambda; x) = \sum_{\substack{p \leq x \\ p \nmid N}} \frac{a_\pi(p) a_{AJ(\Lambda)}(p)}{p^{\frac{1}{2} + \frac{1}{\log x}}} \frac{\log x/p}{\log x}$ and for $V \in \mathbb{R}$ let $A_K(V; x) = \frac{1}{|\text{Cl}_K|} |\{\Lambda \in \widehat{\text{Cl}}_K : P(\Lambda; x) > V\}|$.

Lemma 6.7. *Let $\epsilon > 0$ be sufficiently small. Then for $(\log \log |d|)^{3/4} \leq V \leq \frac{4C_0 \log |d|}{\log \log |d|}$ we have that*

$$A_K(V; |d|^{\frac{1}{\epsilon V}}) \ll_{\pi, \epsilon} \exp \left(\frac{-V^2}{2 \log \log |d|} (1 - 2\epsilon) \right) + e^{-\frac{\epsilon}{4} V \log V}.$$

Proof. Set $x = |d|^{\frac{1}{\epsilon V}}$ and $z = x^{1/\log \log |d|}$. Let

$$P(\Lambda; x) = P_1(\Lambda) + P_2(\Lambda) + P_3(\Lambda)$$

where

$$P_1(\Lambda) = \sum_{\substack{p \leq z \\ p \nmid d, p \nmid N}} \frac{a_\pi(p) a_{\mathcal{AJ}(\Lambda)}(p) \log x/p}{p^{\frac{1}{2} + \frac{1}{\log x}} \log x}, \quad P_2(\Lambda) = \sum_{\substack{z < p \leq x \\ p \nmid d, p \nmid N}} \frac{a_\pi(p) a_{\mathcal{AJ}(\Lambda)}(p) \log x/p}{p^{\frac{1}{2} + \frac{1}{\log x}} \log x},$$

and $P_3(\Lambda) = P(\Lambda; x) - P_1(\Lambda) - P_2(\Lambda)$. Let $V_1 = (1 - \epsilon)V$, $V_2 = \frac{\epsilon}{2}V$. Clearly, if $P(\Lambda; x) > V$ then *i*) $P_1(\Lambda) > V_1$, *ii*) $P_2(\Lambda) > V_2$, or *iii*) $P_3(\Lambda) > V_2$. By Lemma 6.6 we get that the number of $\Lambda \in \widehat{\text{Cl}}_K$ such that *i*) holds is bounded by

$$\frac{1}{V_1^{2\ell}} \sum_{\Lambda \in \widehat{\text{Cl}}_K} P_1(\Lambda)^{2\ell} \ll |\text{Cl}_K| \frac{(2\ell)!}{(V_1^{2/2})^{\ell \ell!}} \left(2 \sum_{\substack{p \leq d \\ \left(\frac{d}{p}\right) = 1, p \nmid N}} \frac{a_\pi(p)^2}{p} \right)^\ell$$

provided that $\ell \leq \frac{1}{3}\epsilon V \log \log |d|$. Applying Lemma 6.4 and Stirling's formula the r.h.s. above is $\ll_{\pi, \epsilon} |\text{Cl}_K| \left(\frac{2\ell \log \log |d| (1 + \epsilon^3)}{V_1^2 e} \right)^\ell$. For $V \leq \frac{1}{3}\epsilon (\log \log |d|)^2$ set $\ell = \lfloor \frac{V^2}{2 \log \log |d|} \rfloor$ and for larger V take $\ell = \lfloor \epsilon V/3 \rfloor$. Hence,

$$(66) \quad \frac{1}{|\text{Cl}_K|} |\{\Lambda \in \widehat{\text{Cl}}_K : P_1(\Lambda) > V_1\}| \ll_{\pi, \epsilon} \exp\left(\frac{-V^2(1 - 2\epsilon)}{2 \log \log |d|}\right) + e^{-\frac{\epsilon}{4}V \log V}.$$

Arguing as before, taking $\ell = \lfloor \epsilon V/3 \rfloor$ and using the bound $|a_\pi(p)|^2 \leq 16$ we have that

$$(67) \quad \begin{aligned} \frac{1}{|\text{Cl}_K|} |\{\Lambda \in \widehat{\text{Cl}}_K : P_2(\Lambda) > V_2\}| &\ll \frac{(2\ell)!}{(V_2^{2/2})^{\ell \ell!}} \left(2 \sum_{\substack{z \leq p \leq x \\ p \nmid N}} \frac{a_\pi(p)^2}{p} \right)^\ell \\ &\ll \left(\frac{65\ell \log \log \log |d|}{V_2^2} \right)^\ell \ll_{\epsilon} e^{-\frac{\epsilon}{4}V \log V}. \end{aligned}$$

Similarly,

$$(68) \quad \frac{1}{|\text{Cl}_K|} |\{\Lambda \in \widehat{\text{Cl}}_K : P_3(\Lambda) > V_2\}| \ll \frac{(2\ell)!}{(V_2^{2/2})^{\ell \ell!}} \left(\sum_{p \nmid d, p \nmid N} \frac{a_\pi(p)^2}{p} \right)^\ell \ll_{\epsilon} e^{-\frac{\epsilon}{4}V \log V}.$$

Combining (66), (67), and (68) completes the proof. \square

6.5. Proof of Theorem 6.1. Let $B_K(V) = \frac{1}{|\text{Cl}_K|} |\{\Lambda \in \widehat{\text{Cl}}_K : \log L(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)) > V\}|$. Observe that

$$(69) \quad \begin{aligned} \frac{1}{|\text{Cl}_K|} \sum_{\Lambda \in \widehat{\text{Cl}}_K} \sqrt{L(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda))} &= \frac{1}{2} \int_{\mathbb{R}} e^{V/2} B_K(V) dV \\ &= \frac{1}{2(\log |d|)^{1/4}} \int_{\mathbb{R}} e^{V/2} B_K(V - \frac{1}{2} \log \log |d|) dV. \end{aligned}$$

It suffices to consider $2(\log \log |d|)^{3/4} \leq V \leq 2C_0 \frac{\log |d|}{\log \log |d|}$ as the contribution of $V \leq 2(\log \log |d|)^{3/4}$ is trivially $O_\epsilon((\log |d|)^{-1/4 + \epsilon})$ and by Remark 6.3 we have $B_K(V) = 0$ for $V \geq 2C_0 \frac{\log |d|}{\log \log |d|}$.

By Lemmas 6.2, 6.4, and (61) we have for $x \leq |d|$ that

$$(70) \quad \log L(\frac{1}{2}, \pi \times \mathcal{AJ}(\Lambda)) \leq P(\Lambda; x) - \frac{1}{2} \log \log |d| + 2C_0 \frac{\log |d|}{\log x} + o(\log \log |d|).$$

Taking $x = |d|^{\frac{1}{\epsilon V}}$ it follows from (70) that $B_K(V - \frac{1}{2} \log \log |d|) \leq A_K(V(1 - 3C_0\epsilon); |d|^{\frac{1}{\epsilon V}})$. Applying the above estimate and using Lemma 6.7 along with the identity

$$\int_{\mathbb{R}} e^{\frac{-t^2}{2 \log \log |d|} + t/2} dt = \sqrt{2\pi \log \log |d|} (\log |d|)^{\frac{1}{8}}$$

we get that the r.h.s. of (69) is

$$\ll (\log |d|)^{-\frac{1}{4}} \int_{2(\log \log |d|)^{3/4}}^{2C_0 \frac{\log |d|}{\log \log |d|}} \left(e^{-\frac{V^2(1-7C_0\epsilon)}{2\log \log |d|}} + e^{-\frac{\epsilon}{5}V \log V} \right) dV + (\log |d|)^{-\frac{1}{4}+\epsilon} \ll_{\pi,\epsilon} \frac{1}{(\log |d|)^{\frac{1}{8}-\epsilon}},$$

which completes the proof. \square
